

## **Regulations of the "December Promotion 2022" promotion (hereinafter: Regulations)**

### **I. Organizer and Duration**

1. The organizer of the promotional campaign "Indigo December Promotion 2022" (hereinafter: "Promotion") is INDIGO NAILS spółka z ograniczoną odpowiedzialnością with its registered office in Łódź, at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Commercial Division of the National Court Register under KRS number: 0000919132, with NIP: 7272792881 and REGON 101805889, (hereinafter: Indigo Nails) and partners Indigo Nails, where it is possible to purchase Products covered by the Promotion in accordance with point II. 2 c), d) and e) of the Regulations (hereinafter referred to as the "Organiser"), while for a specific Participant in the Promotion, the Organizer of the Promotion is always the entity with which the Participant concludes a sales contract.

2. The promotion will run from December 1, 2022 at 10:00:00 (CET GMT +1) to December 31, 2022 at 23:59:59 (CET GMT +1) or until stocks last or cancelled. promotion by the Organizer. (hereinafter: the duration of the Promotion).

### **II. Promotion Terms**

1. Any user, as well as a natural person who performs legal transactions under the conditions set out in the regulations, not directly related to its business or entity, as well as an entity - that is a natural person, legal person and organizational unit referred to in the Promotion, can participate in the Promotion. article 331 § 1 of the Civil Code, we attach our own account to business or investment activity (hereinafter: Participant).

2. The Participant takes part in the Product Promotion by placing an order during its validity:

a. in the Indigo Nails online store at <https://www.indigo-nails.com/>;

b. in the Indigo Nails stationary store at 14/16 Senatorska Street in Łódź. At the same time, the possibility of arising from the Promotion in a stationary store applies to purchases made only between 9:00 - 17:00, from Monday to the process during the Promotion.

c. at distribution points listed on the Indigo Nails website at:

<https://www.indigo-nails.com/pl,punkty-sprzedazy.html>, which participate in the Promotion, or

I know the link to the Promotion through official selling points is true;

d. in online stores run by the above-mentioned;

to me. on the legal basis stated above.

3. The Participant takes part in the Promotion for on-line courses by submitting the obligation to pay for the provision with on-line courses at <https://kursy.indigo-nails.com/>.

4. The Participant takes part in the Promotion for stationary training and workshops at the Indigo Headquarters Training Center in Łódź, Senatorska 14/16, by signing up and paying in a month for the selected training from the automatic schedule for December 2022, January and February 2023. Schedules and contact details for registration can be found at <https://szkolenia.indigo-nails.com/>.

5. The Promotion applies to the Promotion submitted during the validity period both in Poland and abroad.

6. The Participant is obliged not to observe the resale of Products supporting the Promotion in any way, additionally as part of the Participant's business activity. In the event of a breach of the above The Organizer has the right to receive from the Participant a refund of the entire value of the products that the Participant purchased as part of the Promotion, for which the Participant accepts the Regulations and participation in the Promotion, evaluating.

### **III. Promotion Rules**

1. During the Promotion, the Participant may purchase:

- a) Self Leveling Gels building gels in a capacity of 15ml for PLN 53/EUR 13/GBP 11.70. The promotion is applied in the shopping cart.
- b) Indigo hybrid polishes in a capacity of 7 ml in the 2+1 promotion - which means that for the price of 2 products you can buy 3 pieces of the product. The discount is calculated automatically in the basket after adding 3 items of products.
- c) hybrid bases in 7 ml and 13 ml volumes (excluding Protein Base and Protein Base Gold) in the 2+1 promotion. Which means that for the price of 2 products you can buy 3 pieces of the product. The discount is calculated automatically in the basket after adding 3 items of products. The cheapest product is discounted.
- d) hybrid tops in 7 ml and 13 ml in the 2+1 promotion. Which means that for the price of 2 products you can buy 3 pieces of the product. The discount is calculated automatically in the basket after adding 3 items of products. The cheapest product is discounted.
- e) Home Spa sets: Drama Queen, Love Story, Arome 99, Seventh Heaven for PLN 65, EUR 15.50, GBP 14.50. The promotion is applied in the shopping cart.
- f) Home Spa Kit Cream Della Cream Kit for PLN 59, EUR 14.50, GBP 13.50
- g) Drama Queen, Seventh Heaven enzymatic peeling. When you buy 1 scrub, you get a 50% discount on the second one. The promotion is applied in the shopping cart.
- h) calendar for 2023 for PLN 29, EUR 6.9, GBP 6. The promotion is applied in the shopping cart.
- i) -15% on all online courses from the platform <https://kursy.indigo-nails.com/>. The odds on the website are displayed at a discounted price for the duration of the promotion.
- j) -15% on all trainings and stationary workshops that take place at the Indigo Headquarters Training Center in Łódź, at 14/16 Senatorska Street. The discount is valid for the entire December, January and February schedule. Registration and payment must be made in December. Courses in the schedule appear at a discounted price for the entire duration of the promotion.

2. Indigo Nails reserves the right to amend these Regulations during the Promotion, without giving any reason, provided that the rights acquired by the Participants before the amendment will be respected. In particular, Indigo Nails reserves the right to shorten the duration of the Promotion or to exclude individual items from the Promotion due to the exhaustion of stocks.

### **IV. Complaints and returns**

1. Any complaints regarding the way of conducting the Promotion should be reported by the Participants by e-mail to reklamacje@indigo-nails.com or by post to the address of the Organizer's registered office given in point I of the Regulations, with the note: "Promocja December 2022", throughout the duration of the Promotion, however, no later than 14 days from the date of delivery of the order covered by the Promotion.

2. The complaint should contain the following details of the complainant: name, surname and exact address, as well as a detailed description and reason for the complaint, as well as the request of the complainant.

3. Complaints submitted after the deadline or not containing the information referred to in par. 2 will not be considered. The date of submitting the complaint is considered to be:

a) in the case of complaints sent by post - the date of the postmark on the package containing the complaint;

b) in the case of complaints sent electronically - the date of confirmation of receipt of the e-mail by the Organizer.

4. Complaints will be considered immediately, but not later than within 14 days from the date of their receipt by the Organizer.

5. If the provisions of generally applicable law grant the Participant the right to return, the return of products purchased in the Promotion is possible as long as it is a whole set of new and unused items purchased in the Promotion. The return may be made by the customer only in relation to the Organizer within the meaning of point I para. 1 of the Regulations.

## **V. Personal data protection**

1. The administrator of the personal data of the Promotion Participants is the Organizer.

2. Personal data collected in connection with the Promotion will be processed in order to perform the order, for accounting purposes, as well as in the scope of pursuing claims and defending against claims arising from the Sales Agreement - based on the legitimate legal interest of the Administrator, which is pursuing claims and defending against claims .

3. Participants' personal data may be disclosed to entities supporting the Organizer in the implementation of the Promotion, including in particular marketing agencies, courier companies, the Polish Post.

4. In connection with the processing of personal data by the Organizer, Participants have the following rights:

the right to access data and the right to request rectification, deletion or limitation of their processing;

the right to transfer the provided personal data to another administrator;

the right to object to data processing.

5. Participants also have the right to lodge a complaint with the President of the Office for Personal Data Protection.

6. The personal data of the Promotion Participants will be stored for the period in which it will be possible to submit complaints, and in the case of complaints - for the time necessary to consider the complaint.

7. Providing personal data is voluntary, however, it is a necessary condition for the execution of the order. The consequence of not providing personal data will therefore be the inability to complete the order.

8. Personal data will not be transferred outside the EEA.

9. Personal data will not be subject to decisions based solely on automated processing of personal data, including profiling.

## **VI. Final Provisions**

1. These Regulations are available throughout the duration of the Promotion on the website [www.indigo-nails.com](http://www.indigo-nails.com)

2. The Regulations come into force on the day of the Promotion.

3. During the Promotion period, the order processing time may be extended.

4. By participating in the Promotion, the Participant accepts its rules contained in these Regulations and declares that he has read the rules set out in the Regulations and does not raise any objections in this respect.
