

## **“February 2023 Special Offer” Terms and Conditions**

### **I. Organiser and duration**

1. The Organiser of the “February 2023 Special Offer” (hereinafter: “Special Offer”) is INDIGO NAILS spółka z ograniczoną odpowiedzialnością with its registered office in Łódź, at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, 20th Commercial Division of the National Court Register under KRS number: 0000919132, with NIP (Tax Identification Number): 7272792881 and REGON (Polish Business Registry Number) 101805889, (hereinafter: Indigo Nails) and partners of Indigo Nails, where it is possible to purchase Products covered by the Special Offer in accordance with item II sec. 2 c), d) and e) of the Terms and Conditions (hereinafter: “Organiser”), while for a specific Participant of the Special Offer, the Organiser of the Special Offer is always the entity with which the Participant concludes a sales agreement.

2. The Special Offer will run from February 1, 2023 at 10:00:00 (CET GMT +1) until February 28, 2023 at 23:59:59 (CET GMT +1) or until stocks last or it is cancelled by the Organiser (hereinafter: duration of the Special Offer).

### **II. Terms of the Special Offer**

1. Both a consumer, i.e. a natural person performing a legal transaction under the provisions set out in these terms and conditions, not directly related to his/her business or professional activity, as well as an entrepreneur, i.e. a natural person, a legal person and an organizational unit conducting business or professional activity on their own behalf referred to in art. 33<sup>1</sup> § 1 of the Civil Code can participate in the Special Offer (hereinafter: Participant).

In particular, Indigo Nails reserves the right to shorten the duration of the Special Offer or to exclude individual items from the Special Offer due to the exhaustion of stocks.

#### **IV. Complaints and returns**

1. Any complaints regarding the way of conducting the Special Offer should be reported by the Participants by e-mail to [reklamacje@indigo-nails.com](mailto:reklamacje@indigo-nails.com) or by post to the address of the Organiser's registered office specified in item I of the Terms and Conditions, with the note: "February 2023 Special Offer", throughout the duration of the Special Offer, but not later than 14 days from the date of delivery of the order covered by the Special Offer.

2. The complaint should contain the following details of the complainant: name, surname and exact address, as well as a detailed description and reason for the complaint, as well as the request of the complainant.

3. Complaints submitted after the deadline or not containing the information referred to in sec. 2 will not be considered. The date of submitting the complaint is considered to be:

a) in the case of complaints sent by post - the date of the postmark on the package containing the complaint;

b) in the case of complaints sent electronically - the date of confirmation of receipt of the e-mail by the Organiser.

4. Complaints will be considered immediately, but not later than within 14 days from the date of their receipt by the Organiser.

5. If the provisions of generally applicable law grant the Participant the right to return the purchased product, the return of products purchased in the Special Offer is possible as long as it is a whole set of new and unused items purchased in the Special Offer. The return may

be made by the customer only in relation to the Organiser within the meaning of item I sec. 1 of the Terms and Conditions.

## **V. Personal data protection**

1. The controller of the personal data of the Participants is the Organiser.
2. Personal data collected in connection with the Special Offer will be processed in order to perform the order, for accounting purposes, as well as in the scope of pursuing claims and defending against claims arising from the Sales Agreement - based on the legitimate legal interest of the controller, which is the pursuit of claims and defence against claims.
3. Participants' personal data may be disclosed to entities supporting the Organiser in the implementation of the Special Offer, including in particular marketing agencies, courier companies, Poczta Polska (Polish Post).
4. In connection with the processing of personal data by the Organiser, the Participants have the following rights:
  - a) the right to access data and the right to request rectification, deletion or limitation of its processing;
  - b) the right to transfer the provided personal data to another controller;
  - c) the right to object to data processing.
5. Participants also have the right to lodge a complaint with the President of the Office for Personal Data Protection.
6. The personal data of the Participants will be stored for the period in which it will be possible to submit complaints, and in the case of complaints - for the time necessary to consider the complaint.
7. Providing personal data is voluntary, however, it is a necessary condition for the execution of the order. The consequence of not providing personal data will therefore be the inability to complete the order.
8. Personal data will not be transferred outside the EEA.
9. Personal data will not be subject to decisions based solely on automated processing of personal data, including profiling.

## **VI. Final provisions**

1. These Terms and Conditions are available throughout the duration of the Special Offer on the website [www.indigo-nails.com](http://www.indigo-nails.com)
2. The Terms and Conditions come into force on the day the Special Offer starts.
3. During the Special Offer, the order processing time may be extended.

4. By participating in the Special Offer, the Participant accepts the principles contained in these Terms and Conditions and declares that he/she has read the principles set out in the Terms and Conditions and does not raise any objections in this respect.
