

**AMENDMENT dated October 29, 2025. To the Terms and Conditions of the "Indigo Home SPA in Your Salon" Promotion, running since June 24, 2020.**

This amendment introduces the following changes to the Terms and Conditions of the "Indigo Home SPA in Your Salon" Promotion:

**§1.**

Section III regarding the promotion rules is hereby amended and shall read as follows:

1. *During the Promotion Period, any Participant who purchases more than 5 units of **Liquid Hand Wash (370 ml)** shall receive a 10% discount, at a gross price of **PLN 26.10 / EUR 6.84 / GBP 5.85 / USD 8.01** per unit.*

3. *During the Promotion Period, any Participant who purchases more than 10 units of **Hand Creams or Body Lotions (300 ml)** (products may be mixed) shall receive a 15% discount, at a gross price of **PLN 36.55 / EUR 9.35 / GBP 8.25 / USD 8.50** per unit.*
4. *During the Promotion Period, any Participant who purchases between 5 and 10 units of **Sugar Scrubs (300 g)** shall receive a 10% discount, at a gross price of **PLN 44.10 / EUR 10.53 / GBP 9.54** per unit.*
5. *During the Promotion Period, any Participant who purchases more than 10 units of **Sugar Scrubs (300 g)** shall receive a 15% discount, at a gross price of **PLN 41.65 / EUR 9.94 / GBP 9.01** per unit.*
6. *During the Promotion Period, any Participant who purchases between 5 and 10 units of **Shea Butter (70 g)** shall receive a 10% discount, at a gross price of **PLN 30.60 / EUR 7.29 / GBP 6.66 / USD 7.20** per unit.*
7. *During the Promotion Period, any Participant who purchases more than 10 units of **Shea Butter (70 g)** shall receive a 15% discount, at a gross price of **PLN 28.90 / EUR 6.89 / GBP 6.29 / USD 6.80** per unit.*
8. *During the Promotion Period, any Participant who purchases between 5 and 10 units of **Argan Oil (100 ml)** shall receive a 10% discount, at a gross price of **PLN 30.60 / EUR 7.29 / GBP 6.66 / USD 7.20** per unit.*
9. *During the Promotion Period, any Participant who purchases more than 10 units of **Argan Oil (100 ml)** shall receive a 15% discount, at a gross price of **PLN 28.90 / EUR 6.89 / GBP 6.29 / USD 6.80** per unit.*
10. *During the Promotion Period, any Participant who purchases between 5 and 10 units of **Foot Lover Seventh Heaven Foot Cream (100 ml)** shall receive a 10% discount, at a gross price of **PLN 23.40 / EUR 6.12 / GBP 5.22 / USD 7.11** per unit.*

11. *During the Promotion Period, any Participant who purchases more than 10 units of **Foot Lover Seventh Heaven Foot Cream (100 ml)** shall receive a 15% discount, at a gross price of **PLN 22.10 / EUR 5.78 / GBP 4.93 / USD 6.72** per unit.*
12. *During the Promotion Period, any Participant who purchases between 5 and 10 units of **Shea Elixir Cuticle Oil with Keratin (8 ml)** shall receive a 10% discount, at a gross price of **PLN 14.40 / EUR 3.60 / GBP 3.15 / USD 4.41** per unit.*
13. *During the Promotion Period, any Participant who purchases more than 10 units of **Shea Elixir Cuticle Oil with Keratin (8 ml)** shall receive a 15% discount, at a gross price of **PLN 13.60 / EUR 3.40 / GBP 2.98 / USD 4.17** per unit.*
14. *During the Promotion Period, any Participant who purchases between 5 and 10 units of **Protein Serum (8 ml)** shall receive a 10% discount, at a gross price of **PLN 17.10 / EUR 4.23 / GBP 3.60** per unit.*
15. *During the Promotion Period, any Participant who purchases more than 10 units of **Protein Serum (8 ml)** shall receive a 15% discount, at a gross price of **PLN 16.15 / EUR 3.99 / GBP 3.40** per unit.*
16. *During the Promotion Period, any Participant who purchases between 5 and 10 units of **Body Mist (100 ml)** shall receive a 10% discount, at a gross price of **PLN 26.10 / EUR 6.21 / GBP 5.67 / USD 6.30** per unit.*
17. *During the Promotion Period, any Participant who purchases more than 10 units of **Body Mist (100 ml)** shall receive a 15% discount, at a gross price of **PLN 24.65 / EUR 5.87 / GBP 5.36 / USD 5.95** per unit.*
18. *During the Promotion Period, each Participant may place any number of orders.*
19. *This promotion cannot be combined with other offers for the products listed in points 1–17.*
20. *Indigo Nails reserves the right to amend these Terms and Conditions during the Promotion Period without stating a reason, provided that rights acquired by Participants prior to such amendment are respected. In particular, Indigo Nails reserves the right to shorten the Promotion Period or exclude specific items from the Promotion due to stock depletion.*
21. *For any Organizer other than Indigo Nails, the prices indicated in points 1–17 of this section are suggested retail prices only. Before placing an order, each Participant should verify whether the Promotion is active with the given Organizer and whether the promotional price is not higher or lower than stated in these Terms and Conditions.*
22. *The availability of specific products covered by the Promotion may vary depending on the stock levels of the respective branch or distributor.*

## §2.

The amendments to the Regulations shall enter into force on **October 29, 2025**.

## § 3.

The remaining provisions of the Regulations remain unchanged. Accordingly, the current consolidated text of the "Indigo Home SPA in Your Salon" Promotion Regulations is attached as an annex to this amendment.

## **Annex to the Amendment**

### **Consolidated text of the Promotion Regulations**

#### **I. Organizer and Duration of the Promotion**

1. The organizer of the "Indigo Home SPA in Your Salon" promotional campaign (hereinafter: the "**Promotion**") is **INDIGO NAILS spółka z ograniczoną odpowiedzialnością** with its registered office in Łódź, at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, 20th Commercial Division of the National Court Register under KRS number: 0000919132, holding NIP (Tax ID): 7272792881 and REGON: 101805889 (hereinafter: **Indigo Nails**), and partners of Indigo Nails where the purchase of Products covered by the Promotion is possible in accordance with point II section 2 c), d), and e) of the Terms and Conditions (hereinafter: the "**Organizer**"); however, for a specific Promotion Participant, the Organizer of the Promotion is always the entity with which the Participant enters into a sales agreement.
2. The Promotion shall run from **June 24, 2020, from 10:00:00 (Central European Time GMT +1)** until stocks last or until the Promotion is canceled by the Organizer (hereinafter: the "**Promotion Period**").

#### **II. Conditions for Participation in the Promotion**

1. Participation in the Promotion is open to both **consumers**—meaning a natural person performing a legal act under the terms specified in these Regulations, not directly related to their business or professional activity—and **entrepreneurs**—meaning a natural person, a legal person, or an organizational unit referred to in Art. 33<sup>1</sup> § 1 of the Civil Code, conducting business or professional activity in its own name (hereinafter: the "**Participant**").
2. The Participant takes part in the Promotion by placing an order during the Promotion Period:
  - a) at the Indigo Nails online store at <https://www.indigo-nails.com/>;
  - b) at the Indigo Nails UK online store at <https://www.indigo-nails.co.uk/>;
  - c) at an Indigo Nails brick-and-mortar store;
  - d) at one of the official points of sale, the list of which is available on the Indigo Nails website at: <https://www.indigo-nails.com/pl.punkty-sprzedazy.html>, which are participating in the Promotion, as participation in the promotion by official points of sale is voluntary;
  - e) at online stores operated by the entities listed above;
  - f) through sales representatives of the entities listed above.
3. The Promotion applies to orders placed during the Promotion Period both **within the territory of Poland and abroad**.

3. During the Promotion Period, every Participant who purchases more than 10 products from the hand cream or body balm category (300 ml) (products may be mixed) will receive a 15% discount, at a price of PLN 36.55 / EUR 9.35 / GBP 8.25 / USD 8.50 gross per unit.
4. During the Promotion Period, every Participant who purchases between 5 and 10 units of sugar scrubs (300 g) will receive a 10% discount, at a price of PLN 44.10 / EUR 10.53 / GBP 9.54 gross per unit.
5. During the Promotion Period, every Participant who purchases more than 10 units of sugar scrubs (300 g) will receive a 15% discount, at a price of PLN 41.65 / EUR 9.94 / GBP 9.01 gross per unit.
6. During the Promotion Period, every Participant who purchases between 5 and 10 units of Shea Butter (70 g) will receive a 10% discount, at a price of PLN 30.60 / EUR 7.29 / GBP 6.66 / USD 7.20 gross per unit.
7. During the Promotion Period, every Participant who purchases more than 10 units of Shea Butter (70 g) will receive a 15% discount, at a price of PLN 28.90 / EUR 6.89 / GBP 6.29 / USD 6.80 gross per unit.
8. During the Promotion Period, every Participant who purchases between 5 and 10 units of Argan Oil (100 ml) will receive a 10% discount, at a price of PLN 30.60 / EUR 7.29 / GBP 6.66 / USD 7.20 gross per unit.
9. During the Promotion Period, every Participant who purchases more than 10 units of Argan Oil (100 ml) will receive a 15% discount, at a price of PLN 28.90 / EUR 6.89 / GBP 6.29 / USD 6.80 gross per unit.
10. During the Promotion Period, every Participant who purchases between 5 and 10 units of Foot Lover Seventh Heaven foot cream (100 ml) will receive a 10% discount, at a price of PLN 23.40 / EUR 6.12 / GBP 5.22 / USD 7.11 gross per unit.
11. During the Promotion Period, every Participant who purchases more than 10 units of Foot Lover Seventh Heaven foot cream (100 ml) will receive a 15% discount, at a price of PLN 22.10 / EUR 5.78 / GBP 4.93 / USD 6.72 gross per unit.
12. During the Promotion Period, every Participant who purchases between 5 and 10 units of Shea Elixir cuticle oil with keratin (8 ml) will receive a 10% discount, at a price of PLN 14.40 / EUR 3.60 / GBP 3.15 / USD 4.41 gross per unit.
13. During the Promotion Period, every Participant who purchases more than 10 units of Shea Elixir cuticle oil with keratin (8 ml) will receive a 15% discount, at a price of PLN 13.60 / EUR 3.40 / GBP 2.98 / USD 4.17 gross per unit.

14. During the Promotion Period, every Participant who purchases between 5 and 10 units of Protein Serum (8 ml) will receive a 10% discount, at a price of PLN 17.10 / EUR 4.23 / GBP 3.60 gross per unit.
15. During the Promotion Period, every Participant who purchases more than 10 units of Protein Serum (8 ml) will receive a 15% discount, at a price of PLN 16.15 / EUR 3.99 / GBP 3.40 gross per unit.
16. During the Promotion Period, every Participant who purchases between 5 and 10 units of Body Mist (100 ml) will receive a 10% discount, at a price of PLN 26.10 / EUR 6.21 / GBP 5.67 / USD 6.30 gross per unit. *(Note: Point 16 in original likely referred to 5-10 units based on the logic of the previous points).*
17. During the Promotion Period, every Participant who purchases more than 10 units of Body Mist (100 ml) will receive a 15% discount, at a price of PLN 24.65 / EUR 5.87 / GBP 5.36 / USD 5.95 gross per unit.
18. During the Promotion Period, every Participant may place any number of orders.
19. This Promotion cannot be combined with other promotions for the products listed in points 1-17.
20. Indigo Nails reserves the right to amend these Terms and Conditions during the Promotion Period without providing a reason, provided that rights acquired by Participants prior to the amendment are respected. In particular, Indigo Nails reserves the right to shorten the Promotion Period or to exclude specific items from the Promotion due to stock depletion.
21. For any Organizer other than Indigo Nails, the prices indicated in points 1-17 of this section are suggested retail prices only. Before placing an order, each Participant should confirm whether the Promotion is being held by the respective Organizer and whether the price of promotional products is not lower or higher than indicated in these Terms and Conditions.
22. The availability of specific products covered by the Promotion may vary depending on the stock levels of a given branch or distributor.

#### **IV. Complaints and Returns**

1. Any complaints regarding the manner in which the Promotion is conducted should be submitted by Participants via email to [reklamacje@indigo-nails.com](mailto:reklamacje@indigo-nails.com) or by mail to the Organizer's registered office address provided in Section I of the Regulations, with the note: "Indigo Home SPA in Your Salon Promotion." Complaints may be submitted throughout the duration of the Promotion, but no later than 14 days from the date of delivery of the order covered by the Promotion.
2. The complaint should include the following data of the claimant: first name, last name, and exact address, as well as a detailed description and reason for the complaint, and the claimant's specific request.

3. Complaints submitted after the deadline or those not containing the information referred to in paragraph 2 will not be considered.
4. Complaints will be processed immediately, but no later than within 14 days from the date of their receipt by the Organizer.
5. In the event that generally applicable laws grant the Participant the right of return, the return of products purchased under the Promotion is possible only if it constitutes the entire set of new and unused items purchased in the Promotion. Returns may be processed by the customer exclusively through the Organizer as defined in Section I, paragraph 1 of the Regulations.

## V. Personal Data Protection

1. The **Controller** of the Promotion Participants' personal data is the Organizer.
2. Personal data collected in connection with the Promotion will be processed for the purpose of **order fulfillment**, for accounting and financial purposes, as well as for the establishment, exercise, or defense of legal claims arising from the Sales Agreement—based on the Controller's **legitimate legal interest**.
3. Participants' personal data may be disclosed to entities supporting the Organizer in the implementation of the Promotion, including in particular **marketing agencies, courier companies, and Poczta Polska** (the Polish Post).
4. In connection with the processing of personal data by the Organizer, Participants are entitled to the following rights:
  - a) the right to access data and the right to request rectification, erasure, or restriction of processing;
  - b) the right to data portability (transferring data to another controller);
  - c) the right to object to the processing of data.
5. Participants also have the right to **lodge a complaint** with the President of the Personal Data Protection Office (PUODO).
6. Participants' personal data will be stored for the period during which complaints may be submitted, and in the event of a complaint—for the time necessary for its resolution.
7. Providing personal data is **voluntary but necessary** for order fulfillment. Consequently, failure to provide personal data will result in the inability to fulfill the order.
8. Personal data will not be transferred outside the **EEA** (European Economic Area).
9. Personal data will not be subject to decisions based solely on **automated processing**, including profiling.

## VI. Final Provisions

1. The Promotion Terms and Conditions are available at the registered office of each Organizer and on their respective websites.

2. During the Promotion period, **order fulfillment times may be extended**.
3. By participating in the Promotion, the Participant **accepts the rules** contained in these Terms and Conditions and declares that they have read the rules set forth herein and raise no objections in this regard.
