

PROMOTION TERMS AND CONDITIONS

"First Day of Spring – newsletter discount" (hereinafter the "Terms and Conditions").

Preamble

This Promotion is dedicated to **nail stylists** – both those operating their own beauty salons and those performing nail treatments as salon employees or mobile service providers.

By organizing this Promotion, the Organizer aims to support **small business owners** who provide nail styling services using INDIGO NAILS products, including salon owners, employees, and mobile stylists.

Under no circumstances is this Promotion intended for entrepreneurs who, as part of their business activity, sell cosmetic products, including INDIGO NAILS products (distributors, sub-distributors, wholesalers).

The purpose of the Promotion is not for entities professionally engaged in the sale of cosmetic products (including INDIGO NAILS products) to participate in the Promotion, purchase products at lower promotional prices, and subsequently resell them at a higher profit within their retail operations. The Organizer **strongly opposes** such practices. Consequences will be pursued against any individuals or entities who participate in the Promotion despite failing to meet the eligibility criteria.

I. Organizer and Duration of the Promotion

1. The Organizer of the "First Day of Spring – Newsletter Discount" Promotion (hereinafter: the "Promotion"):
 - a) via the online stores <https://www.indigo-nails.com/> and <https://www.indigo-nails.com/eu-de/> is Indigo Nails Sp. z o.o. with its registered office in Łódź at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, 20th Commercial Division of the National Court Register under KRS number: 0001099337, REGON: 528319750, NIP: 7292755541, BDO: 000643230, with a share capital of 10,100,000.00 PLN (hereinafter: Organizer 1).
 - b) via the online stores <https://www.indigo-nails.com/> and <https://www.indigo-nails.com/eu-de/> is Indigo Nails Sp. z o.o. with its registered office in Łódź at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, 20th Commercial Division of the National Court Register under KRS number: 0001099337, REGON: 528319750, NIP: 7292755541, BDO: 000643230, with a share capital of 10,100,000.00 PLN (hereinafter: Organizer 1).

- c) via the online store <https://www.indigo-nails.es/> is INDIGO NAILS ESPANA SL – a company incorporated under Spanish law, entered into the Registradores de España (Barcelona Registry) under NIF number: B10731271, with its registered office at: Calle Gelabert 38, mezzanine 1^a, 08029 Barcelona (hereinafter: Organizer 3).
2. The Promotion may also be organized independently by INDIGO NAILS brand distributors in their respective brick-and-mortar and online stores – participation of a distributor in the Promotion is voluntary.
3. The Promotion shall run exclusively on March 21, 2026, from 00:01 to 23:59 (Central European Time GMT +2); (hereinafter: the Promotion Period).
4. Each Organizer is individually responsible for conducting the Promotion, amending its rules, or canceling it.

II. General Provisions

1. The Promotion shall be conducted in accordance with these Terms and Conditions.
2. Before entering the Promotion, the Participant should read these Terms and Conditions, in particular the eligibility criteria and conditions for participation.
3. By entering the Promotion, the Participant confirms that they have read the Terms and Conditions, understand their provisions, and accept all rules of the Promotion contained therein.

III. Participation in the Promotion

1. The Promotion is open to both consumers—defined as natural persons performing a legal act under the terms of these Regulations not directly related to their business or professional activity—as well as entrepreneurs conducting business or professional activities in their own name, subject to paragraph 2.
2. The Promotion excludes distributors and sub-distributors of nail styling products, wholesalers, and individuals who list products on marketplaces. This exclusion also applies to persons holding representative functions in the aforementioned entities, as well as partners/shareholders of said entities. This exclusion does not apply to entities that do not professionally trade in cosmetic products and perform sales only individually or sporadically, to which the Participant agrees by accepting the Regulations and participating in the Promotion.
3. In the event that any of the persons mentioned in paragraph 2 participate in the Promotion, or if a Participant intends the products purchased under the Promotion for resale, the Organizer shall have the right:
 - a) If the subject of the sale agreement concluded during the Promotion has not yet been delivered: to withdraw from the sale agreement (within 2 months of its conclusion) and withhold delivery, or to demand the difference between the non-promotional price and the price at which the Participant purchased the products under the Promotion, conditioning the delivery upon the payment of said difference—at the Organizer's discretion;
 - b) If the subject of the sale agreement concluded during the Promotion has already been delivered: to withdraw from the sale agreement (within 2 months of its conclusion) and demand the return of the items, or to demand the difference between the

non-promotional price and the price at which the Participant purchased the products under the Promotion—at the Organizer's discretion.

Furthermore, in each of the cases described in paragraph 3, the Organizer may claim from the Participant the reimbursement of logistical costs related to the fulfillment of the promotional order in the amount of €3.20 per item included in the order.

IV. Terms and Conditions of the Promotion

1. To participate in the Promotion, the Participant must place an order during the promotional period at any of the Organizers' online stores: <https://www.indigo-nails.com/>, <https://www.indigo-nails.com/eu-de/>, <https://www.indigo-nails.co.uk/>, or <https://www.indigo-nails.es/>.
2. On March 21, 2026, every subscriber to the newsletter issued by any of the Organizers will receive a discount code. This code entitles the holder to a 10% discount on new SPA fragrances specified in the Annex to the Regulations, available at the aforementioned online stores.
3. The Promotion applies to orders placed during the promotional period with no territorial restrictions, subject to the Organizers' standard delivery terms and conditions.
4. There are no quantity limits on products. However, the discount code can be used only once (per single order). The code is valid exclusively for users logged into their Indigo store account.
5. Participation in the Promotion is entirely voluntary.
6. The discount will be applied automatically in the shopping cart after entering the discount code.
7. This Promotion cannot be combined with any other offers or promotions.
8. The Promotion is valid across all regional branches: PL, DE, ES, UK.

V. Withdrawal from the Sales Agreement

In the event that generally applicable laws grant the Participant the right to withdraw from the sales agreement and return the products, the return of products purchased under the Promotion is possible only if it includes the complete set of new and unused items purchased as part of the Promotion.

VI. Complaints

1. Any complaints regarding the conduct of the Promotion should be submitted via email to the Organizer with whom the Participant placed their order.
2. In the case of a Promotion organized by:
 - a) Organizer 1 – complaints shall be submitted to the address: reklamacje@indigo-nails.com or by mail to the Organizer's registered office address provided in Section I of the Regulations.
 - b) Organizer 2 – complaints shall be submitted to the address: customerservice@indigo-nails.co.uk
 - c) Organizer 3 – complaints shall be submitted to the address: quejas@indigo-nails.es
3. The complaint should include a reference note with the name of the Promotion.

4. Complaints may be submitted throughout the duration of the Promotion, as well as up to 14 days from the date of delivery of the products subject to the sales agreement concluded under the Promotion.
5. The complaint should include the following details of the claimant: first name, last name, and exact address, as well as a detailed description and reason for the complaint, and the claimant's request.
6. Complaints submitted after the deadline or those not containing the information referred to in paragraph 5 will not be considered.
7. Complaints will be processed promptly, but no later than within 30 days from the date of their receipt by the Organizer.

VII. Personal Data Protection

1. The Controller of the Promotion Participants' personal data is the Organizer.
2. Personal data collected in connection with the Promotion will be processed for the purpose of performing the sales contract, for accounting and bookkeeping purposes, as well as for the purpose of pursuing and defending against claims arising from the Sales Contract – based on the Controller's legitimate legal interest, which is the pursuit and defense against claims.
3. Participants' personal data may be disclosed to entities supporting the Organizer in the implementation of the Promotion, including in particular marketing agencies, courier companies, the Postal Operator, a law firm, and an accounting office.
4. In connection with the processing of personal data by the Organizer, Participants have the following rights:
 - a) the right to access data and the right to request their rectification, erasure, or restriction of processing;
 - b) the right to transfer the provided personal data to another controller;
 - c) the right to object to the processing of data.
5. Participants also have the right to lodge a complaint with the President of the Personal Data Protection Office (PUODO).
6. The personal data of the Promotion Participants will be stored for the period during which complaints may be submitted, and in the case of a complaint – for the time necessary to resolve the complaint, until the statute of limitations for claims expires.

Providing personal data is voluntary, however, it is a necessary condition for the performance of the sales contract. Consequently, failure to provide personal data will result in the inability to execute the sales contract.

VIII. Final Provisions

1. These Terms and Conditions are available throughout the entire duration of the Promotion on the following websites: <https://www.indigo-nails.com/>, <https://www.indigo-nails.com/eu-de/>, <https://www.indigo-nails.co.uk>, and <https://www.indigo-nails.es/>.
2. These Terms and Conditions shall enter into force on the start date of the Promotion.
3. During the Promotion period, order processing times may be extended.
4. By participating in the Promotion, the Participant accepts the rules contained in these Terms and Conditions and declares that they have read the rules set out in the Terms and Conditions and do not raise any objections in this regard.

5. The Organizer reserves the right to amend these Terms and Conditions during the Promotion without providing a reason, provided that the rights acquired by Participants prior to the change are respected. In particular, the Organizer reserves the right to shorten the duration of the Promotion.
