PROMOTION TERMS AND CONDITIONS – Neon Colours (hereinafter referred to as the "Terms and Conditions")

Preamble

This Promotion is dedicated to nail stylists – both those who run beauty salons and those who perform nail styling services as employees of beauty salons or as mobile professionals. By organizing this Promotion, the Organizer aims to support small entrepreneurs who provide nail styling services using INDIGO NAILS products – both salon owners and stylists working as employees or mobile professionals.

Under no circumstances is the Promotion intended for entrepreneurs whose business includes the sale of cosmetic products, including INDIGO NAILS products (distributors, sub-distributors, wholesalers).

The purpose of the Promotion is not to allow entities professionally engaged in the sale of cosmetic products, including INDIGO NAILS products, to participate in the Promotion, purchase products at lower promotional prices, and subsequently resell them at a profit. The Organizer firmly opposes such practices and will take action against individuals participating in the Promotion without meeting the eligibility criteria.

Organizer and Promotion Duration

- 1. The organizers of the "Neon Colours" Promotion (hereinafter referred to as the "Promotion") are:

 UNITED BEAUTY LIMITED, a UK company registered at Companies House under number 12076727, VAT: GB332687684, with its registered office at 20-22 Wenlock Road, London, England, N1 7GU (hereinafter referred to as Organizer 2)
 - c. Through the online store https://www.indigo-nails.es/: INDIGO NAILS ESPANA SL, a Spanish company registered in the Registradores de España in the BARCELONA Register under NIF: B10731271, with its registered office at Calle Gelabert 38, mezzanine 1^a, 08029 Barcelona (hereinafter referred to as Organizer 3)
- 2. The Promotion may also be conducted by INDIGO NAILS distributors or other business partners who have joined the Promotion.

- 3. The Promotion will run from **May 30, 2025, 00:01 (Central European Time GMT+2)** until stocks are depleted or until the Promotion is terminated by the Organizer (hereinafter referred to as the "Promotion Period").
- 4. Each Organizer is separately responsible for conducting, modifying the rules of, or terminating the Promotion.

General Provisions

- 1. The Promotion will be carried out in accordance with these Terms and Conditions.
- 2. Before joining the Promotion, Participants should read the Terms and Conditions, particularly the eligibility requirements.
- 3. By joining the Promotion, the Participant confirms they have read, understood, and accepted all the rules set out in these Terms and Conditions.

Participation in the Promotion

- 1. The Promotion is open to both:
 - Consumers, i.e., natural persons performing a legal act under the conditions specified in these Terms and Conditions, not directly related to their business or professional activity,
 - Entrepreneurs conducting business or professional activities in their own name,
 with the exceptions outlined below.
- 2. Distributors and sub-distributors of nail styling products, wholesalers, and individuals listing products on marketplaces are excluded from the Promotion. This exclusion also applies to representatives and partners of such entities.
 - The exclusion does not apply to individuals who do not engage professionally in the sale of cosmetic products and sell only occasionally or individually by accepting these Terms and Conditions, the Participant agrees to this provision.
- 3. If a person listed in point 2 participates in the Promotion or if a Participant purchases products under the Promotion with the intent to resell them, the Organizer has the right to:
 - a. If the subject of the sale agreement has not yet been delivered: withdraw from the sales agreement (within 2 months of its conclusion) and refuse delivery, or require the Participant to pay the difference between the non-discounted product price and the promotional price before releasing the product – at the

Organizer's discretion;

 b. If the product has already been delivered: withdraw from the sales agreement (within 2 months) and request the return of the product or request the payment of the price difference – at the Organizer's discretion.

Additionally, in each case described above, the Organizer may seek reimbursement from the Participant for logistics costs related to fulfilling the promotional order, at the rate of **EUR 3.20 per product** included in the order.

Promotion Conditions

- The Participant joins the Promotion by placing an order during the Promotion Period on any of the Organizers' online stores: https://www.indigo-nails.com/, https://www.indigo-nails.com/, https://www.indigo-nails.com/, https://www.indigo-nails.com/, https://www.indigo-nails.com/.
- 2. The Promotion applies to orders placed during the Promotion Period, with no territorial restrictions, except for the shipping limitations imposed by each Organizer.
- 3. The Promotion offers a **15% discount on Gel Polish products in neon colours**, as specified in **Appendix 1** to these Terms and Conditions.
- 4. Participation in the Promotion is voluntary.
- 5. During the Promotion, each Participant may place an unlimited number of orders.

Withdrawal from the Sales Agreement

If the applicable legal provisions entitle the Participant to withdraw from the sales agreement and return the products, the return of promotional products is possible only if the entire set of purchased items is returned **unused and in new condition**.

Complaints

1. Any complaints regarding the Promotion should be submitted by email to the Organizer through whom the Participant placed the order:

- 2. Complaints should include a note with the name of the Promotion.
- 3. Complaints can be submitted throughout the Promotion Period and up to **14 days from the date of delivery** of the promotional products.
- 4. Complaints must include the following:
 - a. Full name and address of the complainant,
 - b. Detailed description and reason for the complaint,
 - c. Desired resolution.
- 5. Complaints submitted after the deadline or missing the required information will not be considered.
- 6. Complaints will be processed promptly, but no later than **30 days from receipt** by the Organizer.

Personal Data Protection

- 1. The controller of the personal data of the Promotion Participants is the Organizer.
- 2. Personal data collected in connection with the Promotion will be processed for the purposes of executing the sales agreement, for accounting and bookkeeping purposes, as well as for the purposes of pursuing claims and defending against claims arising from the sales agreement based on the legitimate interest of the Organizer (Article 6(1)(b), (c), and (f) of the GDPR).
- 3. Providing personal data is voluntary but necessary to participate in the Promotion. Failure to provide data will prevent participation in the Promotion. The data may be shared with entities providing services to the Organizer (e.g., IT, accounting, logistics, and delivery services), and if necessary with competent authorities, if required by law.
- 4. Personal data will be stored for the duration of the Promotion and the period necessary to fulfill all related obligations (e.g., tax and accounting regulations), and in the case of claims until their expiration in accordance with applicable laws.
- 5. The Participant has the right to request access to their personal data, rectification, erasure, restriction of processing, as well as the right to object to processing and the

- right to lodge a complaint with the supervisory authority in Poland, the President of the Personal Data Protection Office.
- 6. **Participants' personal data** will be stored for the duration during which complaints may be submitted, and in the event of a complaint for the time necessary to process the complaint, until the expiration of any claims.
- 7. Providing personal data is voluntary; however, it is a necessary condition for concluding the sales contract. Therefore, failure to provide personal data will result in the inability to complete the sales contract.

Final Provisions

The Organizer reserves the right to amend these Terms and Conditions during the Promotion without providing a reason, provided that the rights acquired by Participants before the change will be respected. In particular, the Organizer reserves the right to shorten the duration of the Promotion or to exclude specific products from the Promotion due to stock depletion. Such a decision may be made independently by the Organizer.
