Regulations of the promotion "Conference promotion vol. 16", hereinafter referred to as "Regulations".

Preamble

This Promotion and the Contest are dedicated to stylists - both those who run beauty salons, as well as those who perform nail styling as employees of beauty salons or door-to-door. By organizing this Promotion and the Contest, the Organizer wants to support, through price reductions and prizes in kind, smaller entrepreneurs who provide nail styling services with INDIGO NAILS products, both those who run beauty parlors, as well as those who perform nail styling as employees of beauty parlors or ambulant, equalizing their chances on the market and making it possible to obtain products necessary for nail styling at lower prices during the Promotion or as prizes in the Contest, i.e. without financial outlays.

In any case, the Promotion and the Contest are not intended for entrepreneurs who sell cosmetic products, including INDIGO NAILS brand products (distributors, sub-distributors, wholesalers) as part of their business activities.

The purpose of the Promotion and the Contest is not for entities professionally engaged in the sale of cosmetic products, including products of the INDIGO NAILS brand, to participate in the Promotion and the Contest, purchase products at lower promotional prices or win prizes, and then sell the products obtained at a cheaper price or as a prize at an even higher profit for their sales activities. Such actions are strongly opposed by the Organizer, and consequences will be drawn against those who participate in the Promotion and the Contest despite not meeting the conditions of participation.

I. Organizer and duration

- 1. The organizer of the promotional action "Conference Promotion vol. 16" (hereinafter: "Promotion"):
 - a) through the online store https://www.indigo-nails.com/ and https://www.indigo-nails.com/eu-de/ is INDIGO NAILS spółka z ograniczoną odpowiedzialnością with its registered office in Łódź, ul. Senatorska 14/16, 93-192 Łódź, registered in the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Economic Division of the National Court Register under KRS number: 0001099337, having NIP: 7292755541 and REGON: 52831975 (hereinafter: Organizer 1);
 - b) via the online store https://www.indigo-nails.co.uk is UNITED BEAUTY LIMITED a company incorporated under the laws of the United Kingdom, registered at Companies House under the number 12076727, VAT: GB332687684, with its registered office at: 20-22 Wenlock Road, London, England, N1 7GU (hereinafter: Organizer 2);
 - c) through the online store https://www.indigo-nails.es is INDIGO NAILS ESPANA SL a company under Spanish law, registered in the Registradores de Espana, in the Registry of BARCELONA, under NIF number: B10731271, headquartered in : Calle Gelabert 38, mezzanine 1^a, 08029 Barcelona. (hereinafter: Organizer 3).
- 2. The Promotion will last during the Indigo Fall Conference vol. 16, i.e., from 06/09/2025 at 10:00 a.m. until 07/09/2025 at 11:59 p.m. (GMT +1 Central European Time), or until the Promotions are sold out or the Promotions are canceled by the Organizer (hereinafter: the duration of the Promotion or the Conference) whatever comes first.
- 3. Promotions may also be organized by INDIGO NAILS brand distributors on their own in their stationary stores and online the distributor's participation in the Promotion is voluntary.
- 4. Each Organizer is responsible separately for the conduct of the Promotion, changes to its rules or its cancellation.
- 5. The Organizers jointly organize a Competition for the three highest orders placed during the Promotion
 - Promotion. The Contest is related to participation in the Promotion.

II. General Provisions

- 6. The Promotion and the Contest will be held in accordance with these Rules.
- 7. Before entering the Promotion, the Participant should familiarize himself/herself with the Terms and Conditions, in particular the terms and conditions of participation in the Promotion.
- 8. By entering the Promotion, the Participant confirms that he/she has read the Terms and Conditions, understands its provisions and accepts all the rules of the Promotion contained in the Terms and Conditions, including his/her agreement to participate in the Contest, which is related to the organized Promotion.

III. Participation in the Promotion and the Contest

- 9. The Promotion and the Contest may be participated in by a consumer, i.e. a natural person performing a legal action under the terms of these Regulations, not directly related to his/her business or professional activity, as well as an entrepreneur conducting a business or professional activity on his/her own behalf, subject to paragraph 2.
- 10. Distributors, sub-distributors, wholesalers, as well as persons who display products in market squares cannot participate in the Promotion and the Contest the above also applies to persons performing a representative function in the above-mentioned entities, as well as partners in the above-mentioned entities. The exclusion does not apply to entities that do not professionally deal with the sale of cosmetic products, and sell individually or occasionally, to which the Participant, by accepting the Terms and Conditions and participating in the Promotion, agrees.
- 11. In the event that any of the persons listed in paragraph 2 above took part in the Promotion, the Organizer shall have the right:
 - a) if the subject of the sales agreement concluded during the Conference has not been released - withdraw from the sales agreement (within 2 months from its conclusion) and not release the subject of the sales agreement, or demand a refund of the difference between the price of the products not included in the Promotion and the price for which the Participant purchased the products under the Promotion conditioning the release of the subject of the sales agreement on payment of the difference - depending on the decision of the Organizer;
 - b) if the object of the sales agreement concluded during the Conference was released withdraw from the sales agreement (within 2 months from its conclusion) and demand return of the object of sales or demand return of the difference between the price of the products not included in the Promotion and the price for which the Participant purchased the products within the Promotion depending on the decision of the Organizer.
- 12. In the event that any of the persons listed in paragraph 2 or 3 above participated in the Contest and acquired the right to the Prize, the Organizer has the right:
 - a) if the Prize has not been shipped deprive the participant of the right to the Prize due to the lack of fulfillment of the conditions of participation in the Contest, which will entail the lack of shipment of the Prize;
 - b) if the Prize has been shipped deprive the participant of the right to the Prize due to failure to meet the conditions of participation in the Contest, and consequently demand a return of the Prize in kind or demand a refund of the Prize's value depending on the Organizer's decision.
- 13. In addition, in each of the cases described in Paragraphs 3 and 4 above, the Organizer may claim from the Participant reimbursement of logistic costs related to the execution of the order covered by the Promotion and shipping of the Prize in the Contest.
- 14. The Participant undertakes not to sell the products obtained as part of the Prize for winning

the Contest, under pain of the consequences described in Paragraphs 3 and 4.

IV. Terms and Conditions of the Promotion

- 15. The Participant takes part in the Promotion by purchasing products covered by the Promotion from the Organizer during the Promotion.
- 16. The Promotion and the Contest applies to orders placed during the Promotion both in Poland and abroad through stores operated by the Organizers i.e.:

 - d) https://www.indigo-nails.es
- 17. Delivery rules and territorial scope of deliveries are defined separately by each Organizer.
- 18. The promotion includes:
 - a) 2+1 on creams, lotions and hand and body cream in 300 ml capacity which means that three creams can be purchased for the price of two products. This promotion does not apply to novelties. The quantity promotion on creams, lotions and hand and body cream in 300 ml is not valid during this promotion.
 - b) 2+1 on hybrid varnishes excluding novelties and bases and tops, which means that you can purchase three hybrid varnishes for the price of two more expensive varnishes. The promotion does not apply to novelties. The -15% promotion on pastel, glass and neon hybrid varnishes is not valid during this promotion.
 - c) Sets of cosmetics at promotional prices the list and composition of the sets can be found in Appendix 1 to the Regulations.
- 19. The Promotion excludes novelties, i.e. novelties in the field of hybrid varnishes (Gel Polish) and novelties in the field of home spa products (Hand and Body Cream).
- 20. Promotions do not combine.
- 21. Promotions will automatically accrue when you add products to your cart.

V. Terms and conditions of the Promotion

- 22. The organizers will jointly select, in the form of a ranking, the three orders with the highest value placed during the Promotion, within two weeks after the end of the Promotion. The contest will take into account orders placed through the online store https://www.indigo-nails.com/, https://www.indigo-nails.com/eu-de/, https://www.indigo-nails.co.uk, https://www.indigo-nails.es. Participants who have placed 3 orders of the highest value receive the Prize (Winners). Depending on the place they took in the ranking, the Prize takes the form of:
 - a) 1st place Voucher in the amount of PLN 1500;
 - b) II place Voucher in the amount of PLN 1000;
 - c) Third place Voucher in the amount of 500 PLN.
- 23. The vouchers referred to in paragraph 1 will be redeemable indefinitely.
- 24. The Contest will be resolved and the Organizers will announce the names of the Winners' profiles on Instagram within a month after the Conference the announcement will be made on the Instagram portal of each Organizer.
- 25. For the purpose of evaluating the order with the highest value, the amount of orders placed by the Participant through online stores will be counted as follows:
 - a) https://www.indigo-nails.co.uk, in order to standardize the value of transactions, for the purpose of the Organizers' joint Competition, will be converted from British pounds sterling to Polish zlotys, according to the average exchange rate of the National Bank of Poland on the day the order is placed;
 - b) www.indigo-nails.com/eu-de/ https://and https://www.indigo-nails.es in order to standardize the value of transactions, in order for the Organizers to conduct a joint Competition, will be converted from Euros to Polish Zloty, according to the average exchange rate of the National Bank of Poland from the date of placing the order.
- 26. The prizewinners will be informed of the awarding of the prize by the Organizer from whom they purchased the products by e-mail.
- 27. The Laureate is obliged to notify the Organizer from whom he/she received the e-mail message specified in paragraph 4 above of the details for shipping the Prize within 7 days from the date of notification of awarding the Prize.

- 28. The Prize shall be delivered to the Laureate by the Organizer from whom he/she placed the order included in the ranking.
- 29. The Prize is not exchangeable for cash equivalent.
- 30. The Laureate may relinquish the Prize, failure to provide shipping details within 7 days from the date of notification of awarding the Prize is tantamount to relinquishing the Prize.

VI. Shipping costs and duties

- 31. In the case of orders processed outside:
 - a) the territory of the Republic of Poland and the territory of the Federal Republic of Germany (in the case of purchases made from Organizer 1),
 - b) territory of the United Kingdom (in case of purchases made with the Organizer 2)
 - c) the territory of Spain (in case of purchases made with the Organizer 3), the Participant shall bear the cost of shipping the order and any customs fees.
- 32. If the Prize is received by the Participant from outside the territory of the Republic of Poland, the Federal Republic of Germany, the United Kingdom, Spain, the Participant shall bear the cost of shipping the Prize and customs fees related thereto.

VII. Withdrawal from the sales contract and complaints

- 33. In the event that the provisions of common law grant the Participant the right to withdraw from the sales contract and return the products, the return of the products purchased in the Promotion is possible insofar as it constitutes a whole set of new and unused items purchased in the Promotion.
- 34. Any complaints regarding the manner in which the Promotion or the Contest is conducted, Participants should report by email to the Organizer from whom they placed the order.
- 35. In the case of the Promotion organized by:
 - a) Organizer 1 complaints will be submitted to: konferencja@indigo-nails.com;
 - b) Organizer 2 complaints will be reported to the following address: customerservice@indigo-nails.co.uk;
 - c) Organizer 3 complaints will be reported to: quejas@indigo-nails.es.
- 36. In the case of the Contest complaints should be reported to the Organizer from whom the Participant purchased products during the Promotion.
- 37. The complaint should include a note: "Conference Promotion vol.16".
- 38. Complaints regarding the Promotion may be submitted throughout the duration of the Promotion, as well as up to 14 days from the date of release of the products that are the subject of the sales agreement concluded under the Promotion.
- 39. Complaints regarding the Promotion may be submitted for a period of 14 days from the selection of the Winners, and in the case of Winners within 14 days from the date of receipt of the Prize.
- 40. The complaint should contain the following data of the complainant: name, surname and exact address, as well as the exact description and reason for the complaint, as well as the claim of the complainant.
- 41. Complaints submitted after the deadline or not containing the information referred to in paragraph 7 will not be considered. The date of sending the complaint is considered to be:
 - a) in the case of complaints sent by mail the date of the postmark on the parcel containing the complaint;
 - b) in case of complaints sent by e-mail the date of confirmation of receipt of e-mail by the Organizer.
- 42. Complaints will be considered immediately, but no later than within 14 days from the date of their receipt by the Organizer.

VIII. Protection of personal data

- 1. The administrator of the personal data of the Promotion and Contest Participants is the Organizer whose Participant purchased products under the Promotion.
- 2. Personal data collected in connection with the Promotion shall be processed for the purpose of executing the sales agreement, for accounting purposes, as well as for the investigation of claims and defense against claims arising from the Sales Agreement based on the legitimate legal interest of the Administrator, which is the investigation of claims and defense against claims. Personal data is also collected for the purpose of conducting the Contest and shipping the Prize based on the legitimate legal interest of the Organizer which is the conduct of the Contest.
- 3. Participants' personal data may be disclosed to entities supporting the Organizer in the execution of the Promotion, including in particular marketing agencies, courier companies, Postal Operator, law firm, accounting office.
- 4. In connection with the processing of personal data by the Organizer, Participants are entitled to the following rights:
 - a) The right to access the data and the right to request rectification, deletion or restriction of data processing;
 - b) The right to transfer the provided personal data to another administrator;
 - c) The right to object to data processing.
- 5. Participants also have the right to file a complaint to the relevant supervisory authority.
- 6. The personal data of the Promotion Participants will be kept for the period during which it will be possible to make complaints, and in the case of complaints for the time necessary to process the complaint, until the statute of limitations for claims.
- 7. Providing personal data is voluntary, however, it is a prerequisite for the execution of the sales contract. The consequence of not providing personal data will therefore be the inability to execute the sales contract.
- 8. Personal data will not be subject to profiling.
- 9. Personal data will not be transferred outside the EEA or to an international organization.

IX. Final provisions

- 1. These Terms and Conditions are available throughout the Promotion on the websites. Organizers: https://www.indigo-nails.com/, https://www.indigo-nails.com/eu-de/, https://www.indigo-nails.co.uk, https://www.indigo-nails.es.
- 2. The Terms and Conditions shall come into force on the date of commencement of the Promotion.
- 3. During the period of the Promotion, the lead time may be extended.
- 4. Participant, by taking part in the Promotion and Contest, accepts their rules contained in these Regulations and declares that he/she has familiarized himself/herself with its rules, set forth in the Regulations, and does not raise any objections in this regard.
- 5. The Organizers reserve the right to change these Regulations during the Promotion, without giving any reason, with the proviso that the rights acquired by the Participants before the change will be respected. In particular, the Organizers reserve the right to shorten the duration of the Promotion or to exclude particular items from the Promotion as a result of running out of stock.
