TERMS AND CONDITIONS OF THE PROMOTION "Drop Formy Joanna Bandurskiej 100, 200 pcs -50%" (hereinafter "Terms").

Preamble

This Promotion is dedicated to stylists – both those running beauty salons and those who perform nail styling as employees of beauty salons or on a mobile basis.

By organizing this Promotion, the Organizer wants to support smaller entrepreneurs who provide nail styling services using INDIGO NAILS brand products, both those running beauty salons and those who perform nail styling as employees of beauty salons or on a mobile basis.

Under no circumstances is the Promotion intended for entrepreneurs conducting business activity in the sale of cosmetic products, including INDIGO NAILS brand products (distributors, sub-distributors, wholesalers).

The purpose of the Promotion is not for entities professionally involved in the sale of cosmetic products, including INDIGO NAILS products, to participate in the Promotion, purchase products at lower promotional prices, and then sell the products obtained at lower prices for even greater profits for their sales activities. The Organizer strongly opposes such actions, and consequences will be imposed on individuals who participate in the Promotion despite not meeting the participation requirements.

I. Organizer and duration of the Promotion

 - c) via the online store https://www.indigo-nails.es/ is INDIGO NAILS ESPANA SL a company incorporated under Spanish law, entered into the Registradores de Espana register, in the BARCELONA Register, under the NIF number: B10731271, with its registered office at: Calle Gelabert 38, mezzanine 1a, 08029 Barcelona. (hereinafter: Organizer 3).
- 2. The Promotion will run from 21 August 2025 at 6:00 p.m. (announcement of the Promotion in the manner indicated in point IV, item 2) for a period of 48 hours, i.e. until 23 August 2025, 6:00 p.m. (GMT +2 Central European Time).

II. General provisions

1. The Promotion will be conducted in accordance with these Regulations.

- 2. Before participating in the Promotion, the Participant should read the Regulations, in particular the terms and conditions of participation in the Promotion.
- 3. By registering for the Promotion, the Participant confirms that he or she has read the Regulations, understands their provisions and accepts all the rules of the Promotion contained in the Regulations.

III. Participation in the Promotion

- 1. The Promotion may be participated in by both consumers, i.e. natural persons performing legal acts under the terms and conditions specified in these Regulations, not directly related to their business or professional activity, as well as entrepreneurs conducting business or professional activity on their own behalf, subject to paragraph 2.
- 2. <u>are not eligible to participate</u> in the Promotion . This also applies to individuals acting as representatives of the aforementioned entities, as well as partners of the aforementioned entities. This exclusion does not apply to entities that do not professionally sell cosmetic products and sell them on a one-off or occasional basis, to which the Participant consents by accepting the Terms and Conditions and participating in the Promotion.
- 3. If any of the persons mentioned in paragraph 2 participate in the Promotion or if the Participant intends to sell the products purchased in the Promotion, the Organizer has the right to:
 - a) If the subject of the sales contract concluded during the Promotion has not been released withdraw from the sales contract (within 2 months of its conclusion) and not release the subject of the sales contract or demand the difference between the price of the products not covered by the Promotion and the price for which the Participant purchased the products under the Promotion, making the release of the sales item conditional on payment of this difference depending on the decision of the Organizer;
 - b) If the subject of the sales contract concluded during the Promotion has been released withdraw from the sales contract (within 2 months of its conclusion) and demand the return of the sales item or demand the difference between the price of the products not covered by the Promotion and the price for which the Participant purchased the products under the Promotion depending on the decision of the Organizer.
 - Moreover, in each of the cases described in paragraph 3, the Organizer may claim from the Participant reimbursement of logistical costs related to the execution of the order covered by the Promotion in the amount of EUR 3.20 for each item included in the order.

IV. Promotion Terms and Conditions

1. The Organizer will announce the Promotion in the form of a post, story, vlog, or other content via social media, including Instagram, Facebook, TikTok, YouTube, as well as via text messages (for those who have agreed to receive commercial information via text message), a banner on the Organizer's website, a newsletter for those subscribed to the Organizer's newsletter, and a post on Joanna Bandurska's social media. The Promotion post will include a promotional code enabling participation in the Promotion. Promotional codes published in different media will vary, but each code entitles you to participate in the Promotion. A code

- published by a given Organizer entitles you to participate in the Promotion with that Organizer, not with any other Organizer.
- 2. The promotional code will entitle you to purchase the product Joanna Bandurska's forms 100 and 200 pieces in the online store of the Organizer who published the given code, whereby:
 - The discount can apply to a maximum of one product of a given type and size within one order:
 - In case of purchase of more than one product for the same type of product, the discount is calculated for one product;

by the first 100 people who place an order using the code;

- The code is valid for 48 hours from 21.08.2025 18:00 to 23.08.2025 18:00 (CET GMT +2);
- 3. The condition for participating in the Promotion is to go to the DROP tab (upper right corner of the page) and enter the promotional code.
- 4. The discount will be applied automatically in your cart after entering the code.
- 5. Participation in the Promotion is voluntary.
- 6. The promotion cannot be combined with other promotions.

IV. Withdrawal from the sales contract

If the provisions of generally applicable law grant the Participant the right to withdraw from the sales contract and return products, the return of products purchased in the Promotion is possible only <u>if it constitutes the entire set of new and unused items purchased in the Promotion.</u>

V. Complaints

- 1. Participants should submit any complaints regarding the manner of conducting the Promotion by e-mail to the Organizer with whom they placed their order.
- 2. In the case of a Promotion organised by:

- 3. The complaint should include a note with the name of the promotion.
- 4. Complaints can be submitted throughout the duration of the Promotion, as well as within 14 days from the date of delivery of the products that are the subject of the sales contract concluded under the Promotion.
- 5. The complaint should include the following details of the complainant: name, surname and detailed address, as well as a detailed description and reason for the complaint, as well as the complainant's request.
- 6. Complaints submitted after the deadline or not containing the information referred to in paragraph 5 will not be considered.
- 7. Complaints will be considered immediately, but no later than within 30 days of their receipt by the Organizer.

VI. Personal data protection

- 1. The administrator of the personal data of Promotion Participants is the Organizer from whom the Participant purchased products under the Promotion.
- 2. Personal data collected in connection with the Promotion will be processed for the purpose of implementing the sales contract, for accounting and bookkeeping purposes, as well as for the purpose of pursuing claims and defending against claims arising from the sales contract on the basis of the legitimate legal interest of the Controller, which is pursuing claims and defending against claims.
- 3. Participants' personal data may be disclosed to entities supporting the Organizer in the implementation of the Promotion, including in particular marketing agencies, courier companies, the Postal Operator, a law firm, and an accounting office.
- 4. In connection with the processing of personal data by the Organizer, Participants have the following rights:
 - a) the right to access data and the right to request their rectification, deletion or restriction of their processing;
 - b) the right to transfer the provided personal data to another controller;
 - c) the right to object to data processing.
- 5. Participants also have the right to lodge a complaint with the President of the Personal Data Protection Office.
- 6. The personal data of Promotion Participants will be stored for the period in which it will be possible to submit complaints, and in the event of a complaint for the time necessary to consider the complaint, until the limitation period for claims expires.
- 7. Providing personal data is voluntary, but it is a necessary condition for the performance of the sales contract. Failure to provide personal data will result in the inability to perform the sales contract.

VII. Final provisions

- 2. The Regulations come into force on the date of commencement of the Promotion.
- 3. During the Promotion period, order processing times may be extended.
- 4. By taking part in the Promotion, the Participant accepts the rules contained in these Regulations and declares that he or she has become familiar with the rules specified in the Regulations and does not raise any objections in this respect.
- 5. The Organizer reserves the right to change these Terms and Conditions during the Promotion, without providing a reason, provided that the rights acquired by Participants prior to the change will be respected. In particular, the Organizer reserves the right to shorten the Promotion period or exclude individual items from the Promotion due to stock depletion. The Organizer may make such a decision separately.
