

**TERMS AND CONDITIONS OF THE "Registration for the Conference vol.18" PROMOTION
(hereinafter referred to as the "Terms and Conditions").**

Preamble

This Promotion is dedicated to **nail stylists** – both those operating their own beauty salons and those providing nail styling services as salon employees or mobile technicians.

By organizing this Promotion, the Organizer aims to support **small business owners** who provide nail styling services using INDIGO NAILS products, including salon owners, employees, and mobile stylists.

Under no circumstances is this Promotion intended for entrepreneurs whose business activities include the sale of cosmetic products, including INDIGO NAILS products (such as distributors, sub-distributors, and wholesalers).

The purpose of this Promotion is not for professional entities engaged in the sale of cosmetic products, including INDIGO NAILS products, to participate in the Promotion, purchase products at lower promotional prices, and subsequently resell those products at a higher profit margin as part of their sales business. The Organizer **firmly opposes such practices**, and legal or contractual consequences will be pursued against individuals who participate in the Promotion despite not meeting the eligibility requirements.

I. Organizer and Duration of the Promotion

1. The Organizer of the Promotion titled "**Promotion for signing up for the conference vol.18**" (hereinafter: the "**Promotion**"):
 - a) via the online stores <https://www.indigo-nails.com/> and <https://www.indigo-nails.com/eu-de/> is **Indigo Nails Sp. z o.o.** with its registered office in Łódź at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Commercial Division of the National Court Register under KRS number: 0001099337, REGON: 528319750, NIP: 7292755541, BDO: 000643230, with a share capital of 10,100,000.00 PLN (hereinafter: **Organizer 1**)
 - b) via the online store <https://www.indigo-nails.co.uk> is **UNITED BEAUTY LIMITED** – a company incorporated under British law, entered into the Companies House register under number 12076727, VAT: GB332687684, with its registered office at: 20-22 Wenlock Road, London, England, N1 7GU (hereinafter: **Organizer 2**)
 - c) via the online store <https://www.indigo-nails.es/> is **INDIGO NAILS ESPANA SL** – a company incorporated under Spanish law, entered into the Registradores de Espana register, in the BARCELONA Register, under NIF number: B10731271, with its registered office at: Calle Gelabert 38, mezzanine 1^a, 08029 Barcelona (hereinafter: **Organizer 3**).
2. The Promotion shall run from **February 19, 2026, at 8:00 AM** until **March 7, 2026, at 10:00 AM** (Central European Time GMT +1), or until stocks are exhausted, or until the Promotion is cancelled by the Organizer (hereinafter: **Promotion Period**) – whichever occurs first.
3. Each Organizer is individually responsible for conducting the Promotion, amending its rules, or its cancellation.

II. General Provisions

1. The Promotion shall be conducted in accordance with these Terms and Conditions.
2. Prior to participating in the Promotion, the Participant should read these Terms and Conditions, in particular the eligibility requirements and conditions for participation.
 3. By entering the Promotion, the Participant confirms that they have read the Terms and Conditions, understand their provisions, and accept all rules of the Promotion contained herein.

III. Participation in the Promotion

1. The Promotion is open to both **consumers** (natural persons performing a legal act under the terms of these Regulations not directly related to their business or professional activity) and **entrepreneurs** conducting business or professional activity in their own name, subject to paragraph 2.
2. Distributors and sub-distributors of nail styling products, wholesalers, and persons listing products on **marketplaces** are excluded from participation. This exclusion also applies to persons acting in a representative capacity for the aforementioned entities, as well as their partners/shareholders. This exclusion does not apply to entities that do not professionally trade in cosmetic products and perform sales only individually or sporadically, to which the Participant agrees by accepting the Regulations and participating in the Promotion.
3. In the event that any of the persons mentioned in paragraph 2 participate in the Promotion, or if a Participant intends the products purchased under the Promotion for resale, the Organizer reserves the right to:
 - a) **If the subject of the sales contract has not yet been delivered:** withdraw from the sales contract (within 2 months of its conclusion) and withhold delivery, or demand the difference between the standard non-promotional price and the price paid by the Participant, conditioning the delivery on the payment of said difference – at the Organizer's discretion;
 - b) **If the subject of the sales contract has already been delivered:** withdraw from the sales contract (within 2 months of its conclusion) and demand the return of the products, or demand the difference between the standard non-promotional price and the price paid by the Participant – at the Organizer's discretion.
4. Furthermore, in any of the cases described in paragraph 3, the Organizer may claim reimbursement from the Participant for **logistics costs** related to the fulfillment of the promotional order in the amount of **EUR 3.20** for each item included in the order.

IV. Promotion Terms and Conditions

1. A Participant takes part in the Promotion by placing an order during the Promotion Period at the online store of any of the Organizers, i.e., at: <https://www.indigo-nails.com/>, <https://www.indigo-nails.com/eu-de/>, <https://www.indigo-nails.co.uk>, and <https://www.indigo-nails.es/>.
2. The Promotion applies to orders placed during the Promotion Period without territorial restrictions, subject to the Organizer's applicable territorial delivery terms.
3. The Promotion consists of the following: every person who signs up to participate in the Conference will receive a **15% discount code** for spring products listed in Appendix No. 1.
4. The received discount code will be displayed after signing up on the Conference registration page. The code is **valid for 1 hour** from the moment of receipt and can be used by a single user only once.

5. During the Promotion, the gross retail price of the **gel polishes** listed in the appendix, after applying the discount code, is reduced to **PLN 33.14 / EUR 8.41 / GBP 7.23** gross per unit.
6. During the Promotion, the gross retail price of the **dried flowers** listed in the appendix, after applying the discount code, is reduced to **PLN 8.50 / EUR 2.13 / GBP 1.70** gross per unit.
7. During the Promotion, the gross retail price of the **mugs** listed in the appendix, after applying the discount code, is reduced to **PLN 38.25 / USD 10.20 / GBP 9.35** gross per unit.
8. During the Promotion, the gross retail price of the **T-shirts** listed in the appendix, after applying the discount code, is reduced to **PLN 109.65 / EUR 27.20 / GBP 22.10** gross per unit.
9. During the Promotion, the gross retail price of the **Ultra Pigment gel polishes** listed in the appendix, after applying the discount code, is reduced to **PLN 33.14 / EUR 8.42 / GBP 7.23** gross per unit.
10. The Organizers reserve the right that the range of products covered by the Promotion may vary depending on the Organizer from whom the Participant purchases the products.
11. Participation in the Promotion is voluntary.
12. The discount will be applied after entering the discount code.

V. Withdrawal from the Sales Agreement

In the event that the provisions of generally applicable law grant the Participant the right to withdraw from the sales agreement and return the products, the return of products purchased under the Promotion is possible only insofar as it constitutes the entire set of new and unused items purchased under the Promotion.

VI. Complaints

1. Any complaints regarding the conduct of the **Promotion** should be submitted by Participants via email to the **Organizer** with whom they placed their order.
2. In the case of a Promotion organized by:
 - a) **Organizer 1** – complaints shall be submitted to: reklamacje@indigo-nails.com or by mail to the Organizer's registered office address provided in Section I of the Regulations.
 - b) **Organizer 2** – complaints shall be submitted to: customerservice@indigo-nails.co.uk
 - c) **Organizer 3** – complaints shall be submitted to: quejas@indigo-nails.es
3. The complaint should include a reference note containing the **name of the promotion**.
4. Complaints may be submitted throughout the duration of the Promotion, as well as up to **14 days** from the date of delivery of the products subject to the sales agreement concluded under the Promotion.
5. The complaint must contain the following details of the person filing the complaint: **first and last name, full address, a detailed description and reason for the complaint, and the claimant's specific request**.
6. Complaints submitted after the deadline or those missing the information referred to in paragraph 5 will **not be considered**.
7. Complaints will be processed promptly, but no later than within **30 days** from the date of their receipt by the Organizer.

VII. Personal Data Protection

1. **The Controller** of the Promotion Participants' personal data is the Organizer.
2. Personal data collected in connection with the Promotion will be processed for the purpose of

executing the sales contract, for accounting and financial purposes, as well as for the establishment, exercise, or defense of legal claims arising from the Sales Contract—based on the Controller's **legitimate legal interest**, which is the pursuit of and defense against claims.

3. Participants' personal data may be disclosed to entities supporting the Organizer in the implementation of the Promotion, including, in particular: marketing agencies, courier companies, the Postal Operator, law firms, and accounting offices.
4. In connection with the processing of personal data by the Organizer, Participants are entitled to the following rights:
 - a) the right to access data and the right to request its rectification, erasure, or restriction of processing;
 - b) the right to data portability (transferring provided personal data to another controller);
 - c) the right to object to the processing of data.
5. Participants also have the right to **lodge a complaint** with the President of the Personal Data Protection Office (UODO).
6. Personal data of the Promotion Participants will be stored for the period during which complaints may be submitted, and in the case of a complaint—for the time necessary to resolve it, until the **statute of limitations** for claims expires.
7. Providing personal data is **voluntary**, but it is a necessary condition for the execution of the sales contract. Consequently, failure to provide personal data will result in the inability to fulfill the sales contract.

VIII. Final Provisions

1. These Terms and Conditions are available throughout the duration of the Promotion on the following websites: <https://www.indigo-nails.com/>, <https://www.indigo-nails.com/eu-de/>, <https://www.indigo-nails.co.uk>, and <https://www.indigo-nails.es/>.
2. These Terms and Conditions shall enter into force on the date the Promotion commences.
3. During the Promotion period, order processing times may be extended.
4. By participating in the Promotion, the Participant accepts the rules set forth in these Terms and Conditions and declares that they have read the rules specified herein and raise no objections in this regard.
5. The Organizer reserves the right to amend these Terms and Conditions during the Promotion period without stating a reason, provided that rights acquired by Participants prior to such amendments are respected. In particular, the Organizer reserves the right to shorten the duration of the Promotion.
