

**TERMS AND CONDITIONS OF THE "Conference Promotion vol.19" PROMOTION  
(hereinafter referred to as the "Terms and Conditions").**

*Preamble*

*This Promotion and Competition are dedicated to nail stylists – both those operating beauty salons and those performing nail styling services as salon employees or mobile stylists. By organizing this Promotion and Competition, the Organizer aims to support smaller entrepreneurs who provide nail styling services using INDIGO NAILS products (including both salon owners and those working as salon employees or mobile stylists) through price reductions and material prizes. This initiative is designed to level the playing field in the market and enable them to obtain products essential for nail styling at lower prices during the Promotion, or as prizes in the Competition, i.e., without incurring financial costs.*

*Under no circumstances are the Promotion and Competition intended for entrepreneurs whose business activities include the sale of cosmetic products, including INDIGO NAILS brand products (such as distributors, sub-distributors, and wholesalers).*

*The purpose of the Promotion and Competition is not for entities professionally engaged in the sale of cosmetic products, including INDIGO NAILS brand products, to participate in the Promotion and Competition, purchase products at lower promotional prices, or win prizes, and subsequently resell the products obtained at a lower price or as a prize for an even greater profit within their retail business. The Organizer firmly opposes such actions, and consequences will be pursued against individuals who participate in the Promotion and Competition despite not meeting the eligibility criteria.*

**I. Organizer and Duration of the Competition**

1. The organizer of the promotional campaign "Conference Promotion vol. 19" (hereinafter: the "Promotion") is:
  - a) via the online stores <https://www.indigo-nails.com/> and <https://www.indigo-nails.com/eu-de/>: **INDIGO NAILS spółka z ograniczoną odpowiedzialnością** (limited liability company) with its registered office in Łódź, at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Commercial Division of the National Court Register under KRS number: 0001099337, holding NIP (Tax Identification Number): 7292755541 and REGON (Statistical Number): 52831975 (hereinafter: Organizer 1);
  - b) via the online store <https://www.indigo-nails.co.uk/>: **UNITED BEAUTY LIMITED** – a company governed by British law, entered into the Companies House register under number 12076727, VAT: GB332687684, with its registered office at: 20-22 Wenlock Road, London, England, N1 7GU (hereinafter: Organizer 2);

- c) via the online store <https://www.indigo-nails.es/>: **INDIGO NAILS ESPANA SL** – a company governed by Spanish law, entered into the Registradores de Espana register, in the BARCELONA Registry, under NIF number: B10731271, with its registered office at: Calle Gelabert 38, mezzanine 1ª, 08029 Barcelona (hereinafter: Organizer 3).
2. The Promotion will run during the INDIGO NAILS Conference vol. 19, i.e., from May 23, 2026, 10:00 AM to May 25, 2026, 9:00 AM (Central European Time GMT +1), or until stocks last, or until the Promotion is canceled by the Organizer (hereinafter: the Promotion Period or the Conference) – whichever comes first.
3. Promotions may also be organized independently by distributors of the INDIGO NAILS brand in their brick-and-mortar and online stores – the distributor's participation in the Promotion is voluntary.
4. Each Organizer is individually responsible for conducting the Promotion, modifying its rules, or canceling it.
5. The Organizers are jointly organizing a Competition for the three highest orders placed during the Promotion. The Competition is connected with participation in the Promotion.

## **II. General Provisions**

1. The Promotion and the Contest shall be conducted in accordance with these Rules.
2. Before participating in the Promotion, the Participant should read the Rules, in particular the conditions of participation in the Promotion.
3. By entering the Promotion, the Participant confirms that they have read the Rules, understand their provisions, and accept all the principles of the Promotion contained in the Rules, including consenting to take part in the Contest, which is linked to the organized Promotion.

## **III. Participation in the Promotion and the Contest**

1. Both consumers—meaning natural persons performing a legal act under the terms and conditions specified in these Regulations, not directly related to their economic or professional activity—and entrepreneurs conducting economic or professional activity in their own name, may participate in the Promotion and the Contest, subject to para. 2.
2. Distributors, sub-distributors, wholesalers, as well as persons listing products on marketplaces, are excluded from participating in the Promotion and the Contest; the foregoing also applies to persons acting in a representative capacity for the aforementioned entities, as well as partners/shareholders of the aforementioned entities. This exclusion does not apply to entities that do not professionally engage in the sale of cosmetic products and conduct such sales individually or sporadically, to which the Participant agrees by accepting the Regulations and participating in the Promotion.
3. In the event that any of the persons listed in para. 2 above participates in the Promotion, the Organizer shall have the right:
  - a) if the object of the sales contract concluded during the Conference has not yet been delivered – to rescind the sales contract (within 2 months from its conclusion) and

withhold delivery of the object of the sales contract, or to demand payment of the difference between the non-promotional price of the products and the price at which the Participant acquired the products under the Promotion, conditioning the delivery of the object of sale on the payment of such difference – at the Organizer's sole discretion;

- b) if the object of the sales contract concluded during the Conference has already been delivered – to rescind the sales contract (within 2 months from its conclusion) and demand the return of the object of sale, or to demand payment of the difference between the non-promotional price of the products and the price at which the Participant acquired the products under the Promotion – at the Organizer's sole discretion.

4. In the event that any of the persons listed in para. 2 or 3 above participates in the Contest and acquires the right to a Prize, the Organizer shall have the right:

- a) if the Prize has not yet been shipped – to disqualify the participant from the right to the Prize due to failure to meet the conditions for participation in the Contest, which shall result in the non-shipment of the Prize;
- b) if the Prize has already been shipped – to disqualify the participant from the right to the Prize due to failure to meet the conditions for participation in the Contest, and consequently, to demand the return of the Prize in kind or to demand the reimbursement of the value of the Prize – at the Organizer's sole discretion.

5. Furthermore, in each of the cases described in para. 3 and 4 above, the Organizer may claim from the participant the reimbursement of logistics costs related to the fulfillment of the order covered by the Promotion and the shipment of the Prize in the Contest.

6. The Participant undertakes not to resell the products received as a Prize for winning the Contest, under pain of the consequences described in para. 3 and 4.

#### **IV. Terms and Conditions of the Promotion**

### **Terms and Conditions of the Promotion**

1. A Participant takes part in the Promotion by purchasing the products covered by the Promotion from the Organizer during the Promotion Period.
2. The Promotion and the Contest apply to orders placed during the Promotion Period both within Poland and abroad via online stores operated by the Organizers, i.e.:

- d) <https://www.indigo-nails.es>.
3. Delivery rules and the territorial scope of deliveries are determined individually by each Organizer.
4. The Promotion includes:
- a) **A 15% discount** on the Soft Manicure Set – the list, composition, and price of the set can be found in Appendix No. 1 to these Terms and Conditions;
  - b) **A 20% discount** on the Small Set – the list, composition, and price of the set can be found in Appendix No. 2 to these Terms and Conditions;
  - c) **A 25% discount** on the Medium Set – the list, composition, and price of the set can be found in Appendix No. 3 to these Terms and Conditions;
  - d) **A 35% discount** on the All Set – the list, composition, and price of the set can be found in Appendix No. 4 to these Terms and Conditions;
  - e) Upon purchasing the "All Set", a **Mineral Base Effect UV LED Merci 7 ml** will be added to each order as a free gift. The quantity of the product is limited; the promotion is valid while stocks last;
  - f) **A "3+1" offer** on the entire SPA category, excluding the Medium Set and liquid hand wash, which means that any four products from the SPA category can be purchased for the price of the three more expensive products. This promotion combines with the 15% discount;
  - g) **A 10% discount** on bases, tops, and products from the Protein Base category;
  - h) **A 15% discount** on products from the "UV building gels" category;
  - i) **A 5% discount** on the Multi-Technique Dual Brush, which can be purchased at the gross price of 128.25 PLN / 33.73 EUR / 28.79 GBP / 39.24 USD – the list of products participating in the Promotion can be found in Appendix No. 5 to these Terms and Conditions;
  - j) **A 5% discount** on the Gel Brush Oval 6, which can be purchased at the gross price of 66.50 PLN / 17.48 EUR / 14.92 GBP / 20.33 USD – the list of products participating in the Promotion can be found in Appendix No. 5 to these Terms and Conditions;
  - k) **A 15% discount** on Hand & Body Creams (140 ml), which can be purchased at the gross price of 30.60 PLN / 8.08 EUR / 6.89 GBP / 9.35 USD – the list of products participating in the Promotion can be found in Appendix No. 5 to these Terms and Conditions;
  - l) **A 15% discount** on Mini Parfum Twist-off mini perfumes (10 ml), which can be purchased at the gross price of 38.25 PLN / 10.03 EUR / 8.59 GBP / 11.73 USD – the list of products participating in the Promotion can be found in Appendix No. 5 to these Terms and Conditions;
  - m) **A 15% discount** on body mists (150 ml), which can be purchased at the gross price of 46.75 PLN / 12.33 EUR / 10.54 GBP / 14.28 USD – the list of products participating in the Promotion can be found in Appendix No. 5 to these Terms and Conditions;
  - n) **A 15% discount** on body oils (150 ml), which can be purchased at the gross price of 46.75 PLN / 12.33 EUR / 10.54 GBP / 14.28 USD – the list of products participating in the Promotion can be found in Appendix No. 5 to these Terms and Conditions;
  - o) **A 15% discount** on No File Builder Blushy, which can be purchased at the gross price of 42.49 PLN / 10.54 EUR / 9.35 GBP / 12.75 USD – the list of products participating in the Promotion can be found in Appendix No. 5 to these Terms and Conditions;

- p) **Limited sale** of Mini Parfum Twist-off Deja Vu (10 ml) and Mini Parfum Twist-off Alpha Girl (10 ml) perfumes, which will be available exclusively during the Promotion Period with a 5% discount, at the gross price of 45 PLN / 11.80 EUR / 10.10 GBP / 13.80 USD.
5. The Organizers reserve the right that the assortment of products covered by the Promotion may vary depending on the Organizer from whom the Participant purchases the products.
  6. The Organizers reserve the right that during the Promotion, the volume promotion on the "Hugo Gloss" top coat product and the "2+1" promotion on the "Mineral Base with effect" are deactivated.
  7. Promotions cannot be combined.
  8. Discounts will be applied automatically after adding the products to the shopping cart.
  9. Participation in the Promotion is voluntary.

## V. Competition Terms and Conditions

1. Within two weeks from the end of the Promotion, the Organizers will jointly select and rank the three highest-value orders placed during the Promotion period. The competition will take into account orders placed through the following online stores: <https://www.indigo-nails.com/>; <https://www.indigo-nails.com/eu-de/>; <https://www.indigo-nails.co.uk/>; <https://www.indigo-nails.es/>. The Participants who placed the 3 highest-value orders will receive a Prize (hereinafter: Winners). Depending on their position in the ranking, the Prize shall be as follows:

**1st place** – Voucher worth 1500 PLN / 350 EUR / 305 GBP;

**2nd place** – Voucher worth 1000 PLN / 235 EUR / 200 GBP;

**3rd place** – Voucher worth 500 PLN / 115 EUR / 100 GBP;

2. The Vouchers referred to in paragraph 1 will have no expiration date.
3. The competition will be resolved, and the Organizers will publish the profile names of the Winners on Instagram within one month from the Conference – the announcement will be made on the Instagram profile of each Organizer.
4. For the purpose of evaluating the highest-value orders, the value of the orders placed by the Participant through the online stores will be calculated as follows:
  - a) Orders from <https://www.indigo-nails.co.uk/> will be converted from British Pounds Sterling (GBP) to Polish Zloty (PLN) according to the average exchange rate of the National Bank of Poland (NBP) from the date the order was placed, in order to standardize the transaction values for the purpose of conducting the joint Competition by the Organizers;
  - b) Orders from <https://www.indigo-nails.com/eu-de/> and <https://www.indigo-nails.es/> will be converted from Euro (EUR) to Polish Zloty (PLN) according to the average exchange rate of the National Bank of Poland (NBP) from the date the order was

placed, in order to standardize the transaction values for the purpose of conducting the joint Competition by the Organizers.

5. The Winners will be notified of the prize award by the Organizer from whom they purchased the products via an e-mail message.
6. The Winner is obliged to provide the shipping details for the Prize to the Organizer from whom they received the e-mail message specified in paragraph 5 above, within 7 days from the date of the prize award notification.
7. The Prize will be delivered to the Winner by the Organizer with whom the ranked order was placed.
8. The Prize is not exchangeable for cash equivalent.
9. The Winner may waive the Prize; failure to provide shipping details within 7 days from the date of the prize award notification is equivalent to waiving the Prize.

## **VI. Shipping Costs and Customs Duties**

1. In the case of orders fulfilled outside:
  - a) the territory of the Republic of Poland and the territory of the Federal Republic of Germany (for purchases made from Organizer 1);
  - b) the territory of the United Kingdom (for purchases made from Organizer 2);
  - c) the territory of Spain (for purchases made from Organizer 3); the Participant shall bear the cost of order shipping and any applicable customs duties.
2. In the event that a Prize is awarded to a Participant from outside the territory of the Republic of Poland, the Federal Republic of Germany, the United Kingdom, or Spain, the Participant shall bear the cost of shipping the Prize and any associated customs duties.

## **VII. Withdrawal from the Sales Agreement and Complaints**

1. In the event that the provisions of generally applicable law grant the Participant the right to withdraw from the sales agreement and return the products, the return of products purchased under the Promotion is possible provided that they constitute a complete set of new and unused items purchased under the Promotion.
2. Any complaints regarding the manner of conducting the Promotion or the Competition should be submitted by Participants via e-mail to the Organizer with whom they placed the order.
3. In the case of a Promotion organized by:
  - a) **Organizer 1** – complaints shall be submitted to the following address: konferencja@indigo-nails.com;

- c) **Organizer 3** – complaints shall be submitted to the following address:

4. In the case of the Competition – complaints should be submitted to the Organizer from whom the Participant purchased the products during the Promotion period.
  5. The complaint should include the following reference: "Conference Promotion vol. 18".
  6. Complaints regarding the Promotion may be submitted throughout the entire duration of the Promotion, as well as up to 14 days from the date of delivery of the products subject to the sales agreement concluded under the Promotion.
  7. Complaints regarding the Competition may be submitted for a period of 14 days from the selection of the Winners, and in the case of Winners – within 14 days from the date of receipt of the Prize.
  8. The complaint should include the following details of the person submitting the complaint: first name, last name, and exact address, as well as a detailed description and reason for the complaint, along with the claimant's request.
  9. Complaints submitted after the deadline or not containing the information referred to in paragraph 7 will not be considered. The date of submission of the complaint shall be deemed to be:
    - a) in the case of complaints sent by post – the date of the postmark on the package containing the complaint;
    - b) in the case of complaints sent electronically – the date of confirmation of receipt of the e-mail by the Organizer.
  10. Complaints will be considered immediately, but no later than within 14 days from the date of their receipt by the Organizer.

### **VIII. Personal Data Protection**

1. The controller of the Promotion and Competition Participants' personal data is the Organizer from whom the Participant purchased the products under the Promotion.
2. Personal data collected in connection with the Promotion will be processed for the purpose of executing the sales contract, for accounting and financial purposes, as well as for the establishment, exercise, or defense of legal claims arising from the Sales Contract – based on the legitimate legal interest of the Controller, which is the pursuit and defense of claims. Personal data is also collected for the purpose of conducting the Competition and dispatching the Prizes – based on the legitimate legal interest of the Organizer, which is the execution of the Competition.
3. Participants' personal data may be disclosed to entities supporting the Organizer in the execution of the Promotion, including in particular marketing agencies, courier companies, the Postal Operator, a law firm, and an accounting office.
4. In connection with the processing of personal data by the Organizer, Participants are entitled to the following rights:
  - a) the right of access to data and the right to request their rectification, erasure, or restriction of their processing;

- b) the right to data portability (to transfer the provided personal data to another controller);
  - c) the right to object to the processing of data.
5. Participants also have the right to lodge a complaint with the competent supervisory authority.
  6. The personal data of the Promotion Participants will be stored for the period during which complaints can be submitted, and in the event of a complaint – for the time necessary to resolve the complaint, until the expiry of the limitation period for claims.
  7. Providing personal data is voluntary, however, it constitutes a necessary condition for the execution of the sales contract. Consequently, failure to provide personal data will result in the inability to execute the sales contract.
  8. Personal data will not be subject to profiling.
  9. Personal data will not be transferred outside the EEA (European Economic Area) or to any international organization.

## **IX. Final Provisions**

1. These Terms and Conditions are available throughout the entire duration of the Promotion on the Organizers' websites: <https://www.indigo-nails.com/>; <https://www.indigo-nails.com/eu-de/>; <https://www.indigo-nails.es> and <https://www.indigo-nails.co.uk>.
2. These Terms and Conditions shall enter into force on the starting date of the Promotion.
3. During the Promotion period, order processing times may be extended.
4. By participating in the Promotion and the Contest, the Participant accepts their rules contained in these Terms and Conditions and declares that they have read the rules specified in the Terms and Conditions and raise no objections in this regard.
5. The Organizers reserve the right to amend these Terms and Conditions during the Promotion without giving any reason, provided that the rights acquired by the Participants prior to the amendment will be respected. In particular, the Organizers reserve the right to shorten the duration of the Promotion or to exclude individual items from the Promotion due to stock depletion.
