

TERMS AND CONDITIONS OF THE PROMOTION "International Fruit Day" (hereinafter referred to as the "Terms and Conditions").

Preamble

This Promotion is dedicated to nail stylists – both those operating beauty salons and those performing nail styling services as salon employees or mobile stylists.

By organizing this Promotion, the Organizer wishes to support smaller entrepreneurs who provide nail styling services using INDIGO NAILS products, including both those operating beauty salons and those who perform nail styling services as salon employees or mobile stylists.

Under no circumstances is the Promotion intended for entrepreneurs whose business activities include the sale of cosmetic products, including INDIGO NAILS products (distributors, sub-distributors, wholesalers).

The purpose of the Promotion is not for entities professionally engaged in the sale of cosmetic products, including INDIGO NAILS products, to participate in the Promotion, purchase products at lower promotional prices, and subsequently resell the products obtained at a lower price with an even higher profit for their sales business. The Organizer strongly opposes such actions, and consequences will be enforced against individuals who participate in the Promotion despite not meeting the eligibility criteria.

I. Organizer and Duration of the Promotion

1. The organizer of the "International Fruit Day" promotion (hereinafter: the "Promotion"):
 - a) via the online store <https://www.indigo-nails.com/> and <https://www.indigo-nails.com/eu-de/> is **Indigo Nails Sp. z o.o.** with its registered office in Łódź at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, 20th Commercial Division of the National Court Register under KRS number: 0001099337, REGON: 528319750, NIP: 7292755541, BDO: 000643230, with a share capital of PLN 10,100,000.00 (hereinafter: Organizer 1);
 - b) via the online store <https://www.indigo-nails.co.uk> is **UNITED BEAUTY LIMITED** – a company incorporated under British law, entered into the Companies House register under number 12076727, VAT: GB332687684, with its registered office at: 20-22 Wenlock Road, London, England, N1 7GU (hereinafter: Organizer 2);
 - c) via the online store <https://www.indigo-nails.es/> is **INDIGO NAILS ESPANA SL** – a company incorporated under Spanish law, entered into the Registradores de España register, in the BARCELONA Registry, under NIF number: B10731271, with its registered office at: Calle Gelabert 38, mezzanine 1ª, 08029 Barcelona (hereinafter: Organizer 3).
2. The Promotion may also be organized independently by distributors of the INDIGO NAILS brand in their brick-and-mortar and online stores – the distributor's participation in the Promotion is voluntary.
3. The Promotion shall run on **July 1, 2026, from 09:00 AM until July 1, 2026, at 11:59 PM**

(Central European Time GMT +2) or until stocks last, or until the Promotion is canceled by the Organizer (hereinafter: Duration of the Promotion) – whichever occurs first.

4. Each Organizer is individually responsible for conducting the Promotion, changing its rules, or canceling it.

II. General Provisions

1. The Promotion shall be conducted in accordance with these Terms and Conditions.
2. Prior to participating in the Promotion, the Participant should read these Terms and Conditions, in particular the conditions for participation in the Promotion.
3. By entering the Promotion, the Participant confirms that they have read the Terms and Conditions, understand their provisions, and accept all the rules of the Promotion contained herein.

III. Participation in the Promotion

1. The Promotion is open to both consumers—defined as natural persons executing a legal transaction under the terms and conditions specified in these Regulations for purposes not directly related to their business or professional activity—and entrepreneurs conducting business or professional activity in their own name, subject to section 2.
2. Distributors and sub-distributors of nail styling products, wholesalers, as well as individuals who list products on online marketplaces are excluded from participating in the Promotion; this exclusion also applies to persons holding representative roles in the aforementioned entities, as well as partners/shareholders of the aforementioned entities. This exclusion does not apply to entities that do not professionally deal in the sale of cosmetic products and perform such sales individually or sporadically, to which the Participant agrees by accepting the Regulations and participating in the Promotion.
3. In the event that any of the persons listed in section 2 participate in the Promotion, or in the event that a Participant intends the products purchased under the Promotion for resale, the Organizer shall have the right to:
 - a) If the subject matter of the sales contract concluded during the Promotion has not yet been delivered – to rescind the sales contract (within 2 months from its conclusion) and withhold delivery of the subject matter of the sales contract, or to demand the difference between the regular, non-promotional price of the products and the price at which the Participant acquired the products under the Promotion, making the delivery of the subject matter of sale conditional upon the payment of said difference – at the Organizer's sole discretion;
 - b) If the subject matter of the sales contract concluded during the Promotion has already been delivered – to rescind the sales contract (within 2 months from its conclusion) and demand the return of the subject matter of sale, or to demand the difference between the regular, non-promotional price of the products and the price at which the Participant acquired the products under the Promotion – at the Organizer's sole discretion.

Furthermore, in each of the cases described in section 3, the Organizer may claim from the Participant the reimbursement of logistics costs related to the fulfillment of the order covered by the Promotion, in the amount of EUR 3.20 for each item comprising the order.

IV. Promotion Terms and Conditions

1. A Participant takes part in the Promotion by placing an order during its term in the online store of any of the Organizers, i.e., <https://www.indigo-nails.com/>, at <https://www.indigo-nails.com/eu-de/>, <https://www.indigo-nails.co.uk/>, and <https://www.indigo-nails.es/>.
2. The Promotion applies to orders placed during the term of the Promotion without territorial restrictions, subject to the territorial delivery terms applicable to the given Organizer.
3. On July 1, 2026, every subscriber to the newsletter issued by any of the Organizers, as well as any person who views the story shared on the Organizers' profile on the Instagram social media platform via Stories, will receive information about the promotion and the opportunity to purchase Foodie 1 and 2 stamping plates, selected gel polishes with fruit-themed names, and selected 370ml Hand&Body Creams with fruity scents at a -15% discount. The list of products covered by the promotion constitutes Appendix No. 1 to these Terms and Conditions.
4. The Promotion is not subject to any quantitative limits, meaning that the Participant may purchase any number of products at the promotional price, subject to their current availability in the Organizer's online store.
5. Participation in the Promotion is voluntary.
6. The discount will be applied automatically in the shopping cart after entering the discount code.
7. The Promotion cannot be combined with other promotions.

V. Withdrawal from the Sales Agreement

In the event that the provisions of generally applicable law grant the Participant the right to withdraw from the sales agreement and return the products, the return of products purchased under the Promotion is possible provided that it constitutes the entire set of new and unused items purchased under the Promotion.

VI. Complaints

1. Any complaints regarding the conduct of the Promotion should be submitted by Participants via email to the Organizer with whom they placed the order.
2. In the case of a Promotion organized by:
 - a) Organizer 1 – complaints shall be submitted to the address: reklamacje@indigo-nails.com or by post to the Organizer's registered office address specified in Section I of the Regulations.
 - b) Organizer 2 – complaints shall be submitted to the address: customerservice@indigo-nails.co.uk
 - c) Organizer 3 – complaints shall be submitted to the address: quejas@indigo-nails.es
3. The complaint should include a reference note containing the name of the promotion.
4. Complaints may be submitted throughout the entire duration of the Promotion, as well as up to 14 days from the date of delivery of the products subject to the sales contract concluded under the Promotion.
5. The complaint should contain the following details of the person submitting the complaint: first name, last name, and exact address, as well as a detailed description and reason for the complaint, along with the claimant's demand.
6. Complaints submitted after the deadline or not containing the information

referred to in paragraph 5 will not be considered.

7. Complaints will be reviewed promptly, but no later than within 30 days from the date of their receipt by the Organizer.

VII. Personal Data Protection

1. The controller of the Promotion Participants' personal data is the Organizer.
2. Personal data collected in connection with the Promotion will be processed for the purpose of executing the sales contract, for accounting and bookkeeping purposes, as well as for the establishment, exercise, or defense of legal claims arising from the Sales Contract – based on the legitimate legal interest of the Controller, which is the pursuit and defense of claims.
3. Participants' personal data may be disclosed to entities supporting the Organizer in the implementation of the Promotion, including in particular marketing agencies, courier companies, the Postal Operator, a law firm, and an accounting office.
4. In connection with the processing of personal data by the Organizer, Participants are entitled to the following rights:
 - a) the right to access the data and the right to request its rectification, erasure, or restriction of its processing;
 - b) the right to data portability of the provided personal data to another controller;
 - c) the right to object to the processing of data.
5. Participants also have the right to lodge a complaint with the President of the Personal Data Protection Office (UODO).
6. Personal data of the Promotion Participants will be stored for the period during which complaints can be submitted, and in the case of a complaint – for the time necessary to resolve the complaint, until the statute of limitations for claims expires.
7. Providing personal data is voluntary, but it constitutes a necessary condition for the performance of the sales contract. Consequently, failure to provide personal data will result in the inability to execute the sales contract.

VIII. Final Provisions

1. These Terms and Conditions are available throughout the duration of the Promotion on the following websites: <https://www.indigo-nails.com/>, <https://www.indigo-nails.com/eu-de/>, <https://www.indigo-nails.co.uk>, and <https://www.indigo-nails.es/>.
2. These Terms and Conditions shall enter into force on the start date of the Promotion.
3. Order processing times may be extended during the Promotion period.
4. By participating in the Promotion, the Participant accepts the rules contained in these Terms and Conditions, declares that they have read the rules specified herein, and raises no objections in this regard.
5. The Organizer reserves the right to amend these Terms and Conditions during the Promotion period without giving any reason, provided that the rights acquired by the Participants prior to the amendment are respected. In particular, the Organizer reserves the right to shorten the duration of the Promotion.
