

TERMS AND CONDITIONS OF THE "-15% off Gel Polish glitter" PROMOTION (hereinafter the "Terms and Conditions")

Preamble

This Promotion is dedicated to stylists – both those running beauty salons and those who perform nail styling as employees of beauty salons or as mobile stylists. By organizing this Promotion, the Organizer aims to support smaller entrepreneurs who provide nail styling services using INDIGO NAILS products, including those running beauty salons, as well as those who perform nail styling as employees of beauty salons or as mobile stylists.

Under no circumstances is the Promotion intended for entrepreneurs who, as part of their business activity, sell cosmetic products, including INDIGO NAILS products (distributors, sub-distributors, wholesalers).

The purpose of the Promotion is not for entities professionally involved in the sale of cosmetic products, including INDIGO NAILS products, to participate in the Promotion, purchase products at lower promotional prices, and subsequently sell the products obtained at a lower price for an even greater profit for their sales business. The Organizer strongly opposes such activities, and consequences will be taken against individuals who participate in the Promotion despite not meeting the participation requirements.

I. Organizer and Duration of the Promotion

1. The Organizer of the "-15% off Gel Polish glitter" Promotion (hereinafter: "Promotion"):
 - a) via the online stores <https://www.indigo-nails.com/> and <https://www.indigo-nails.com/eu-de/> is **Indigo Nails Sp. z o.o.** with its registered office in Łódź at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Commercial Division of the National Court Register under KRS number: 0001099337, REGON: 528319750, NIP: 7292755541, BDO: 000643230, with a share capital of PLN 10,100,000.00 (hereinafter: Organizer 1).
 - b) via the online store <https://www.indigo-nails.co.uk> is **UNITED BEAUTY LIMITED** – a company incorporated under British law, entered into the Companies House register under number 12076727, VAT: GB332687684, with its registered office at: 20-22 Wenlock Road, London, England, N1 7GU (hereinafter: Organizer 2).
 - c) via the online store <https://www.indigo-nails.es/> is **INDIGO NAILS ESPANA SL** – a company incorporated under Spanish law, entered into the Registradores de Espana, in the BARCELONA Register, under NIF number: B10731271, with its registered office at: Calle Gelabert 38, mezzanine 1^a, 08029 Barcelona (hereinafter: Organizer 3).
2. The Promotion may also be organized by INDIGO NAILS distributors and other brand partners, provided they have joined the Promotion.
3. The Promotion shall run from **January 7, 2026, 00:01 AM (Central European Time GMT +2)** until stocks last or until the Promotion is canceled by the Organizer (hereinafter: Promotion Duration).
4. Each Organizer is independently responsible for conducting the Promotion, changing its rules, or canceling it.

II. General Provisions

1. The Promotion shall be conducted in accordance with these Terms and Conditions.

2. Before participating in the Promotion, the Participant should read the Terms and Conditions, in particular the conditions for participation in the Promotion.
3. By entering the Promotion, the Participant confirms that they have read the Terms and Conditions, understand their provisions, and accept all the Promotion rules contained in the Terms and Conditions.

III. Participation in the Promotion

1. Both consumers—defined as natural persons performing a legal act under the terms specified in these Regulations not directly related to their business or professional activity—and entrepreneurs conducting business or professional activity in their own name may participate in the Promotion, subject to section 2.
2. Distributors and sub-distributors of nail styling products, wholesalers, and individuals who list products on marketplaces are excluded from participating in the Promotion; this also applies to persons acting in a representative capacity for the aforementioned entities, as well as partners of said entities. This exclusion does not apply to entities that do not professionally engage in the sale of cosmetic products and conduct such sales only individually or occasionally, to which the Participant agrees by accepting the Regulations and participating in the Promotion.
3. In the event that any of the persons mentioned in section 2 participate in the Promotion, or if the Participant intends the products purchased in the Promotion for resale, the Organizer has the right to:
 - a) **If the item of the sales contract concluded during the Promotion has not yet been delivered:** withdraw from the sales contract (within 2 months of its conclusion) and refuse to deliver the item, or demand the difference between the non-promotional price of the products and the price at which the Participant purchased the products under the Promotion, conditioning the delivery of the item on the payment of this difference—depending on the Organizer's decision;
 - b) **If the item of the sales contract concluded during the Promotion has already been delivered:** withdraw from the sales contract (within 2 months of its conclusion) and demand the return of the item, or demand the difference between the non-promotional price of the products and the price at which the Participant purchased the products under the Promotion—depending on the Organizer's decision.
4. Furthermore, in each of the cases described in section 3, the Organizer may claim from the Participant the reimbursement of logistical costs related to the fulfillment of the promotional order in the amount of EUR 3.20 for each item included in the order.

IV. Terms of the Promotion

1. A Participant takes part in the Promotion by placing an order during its term in the online store of any of the Organizers, i.e., at: <https://www.indigo-nails.com/>, <https://www.indigo-nails.com/eu-de/>, <https://www.indigo-nails.co.uk>, and <https://www.indigo-nails.es/>.
2. The Promotion applies to orders placed during the term of the Promotion without territorial restrictions, subject to the Organizer's applicable territorial delivery terms.
3. **he Promotion consists of a 15% reduction in the price of the following products during the term of the Promotion: INDIGO NAILS Gel Polish glitter hybrid polishes as specified in Annex No. 1 to the Regulations.**
4. **During the Promotion, the unit price of the product is reduced:**
 - from PLN 38.99 to PLN 33.14;
 - from € 9.90 to € 8.42;

- **from £ 8.50 to £ 7.23;**
- **from \$11.60 to\$ 9.86;**

5. Participation in the Promotion is voluntary.
6. During the term of the Promotion, each Participant may place any number of orders.
7. The availability of specific products covered by the Promotion may vary depending on the stock levels of a given branch or distributor.

V. Withdrawal from the Sales Contract

In the event that the provisions of generally applicable law grant the Participant the right to withdraw from the sales contract and return products, the return of products purchased under the Promotion is possible only if it constitutes the entire set of new and unused items purchased within the Promotion.

VI. Complaints

1. Any complaints regarding the conduct of the Promotion should be submitted via e-mail to the Organizer with whom the order was placed.
2. In the case of a Promotion organized by:
 - a) **Organizer 1** – complaints shall be submitted to: reklamacje@indigo-nails.com or by post to the Organizer's registered office address provided in Section I of the Regulations.
 - b) **Organizer 2** – complaints shall be submitted to: customerservice@indigo-nails.co.uk
 - c) **Organizer 3** – complaints shall be submitted to: quejas@indigo-nails.es
3. The complaint should include a note with the name of the promotion.
4. Complaints may be submitted throughout the duration of the Promotion, as well as up to **14 days** from the date of delivery of the products subject to the sales agreement concluded under the Promotion.
5. The complaint should contain the following data of the claimant: first name, last name, and exact address, as well as a detailed description and reason for the complaint, and the claimant's request.
6. Complaints submitted after the deadline or not containing the information referred to in paragraph 5 will not be considered.
7. Complaints will be processed immediately, but no later than within **30 days** from the date of their receipt by the Organizer.

VII. Personal Data Protection

1. The Organizer is the controller of the Participants' personal data.
2. Personal data collected in connection with the Promotion will be processed for the purpose of performing the sales agreement, for accounting and bookkeeping purposes, as well as for the pursuit of claims and defense against claims resulting from the Sales Agreement – based on the Controller's **legitimate legal interest**, which is the pursuit of and defense against claims.
3. Participants' personal data may be disclosed to entities supporting the Organizer in the implementation of the Promotion, including in particular marketing agencies, courier companies, the Postal Operator, law firms, and accounting offices.
4. In connection with the processing of personal data by the Organizer, Participants have the following rights:
 - a) the right to access data and the right to request their rectification, erasure, or restriction of processing;
 - b) the right to transfer the provided personal data to another controller;
 - c) the right to object to the processing of data.

5. Participants also have the right to lodge a complaint with the President of the Personal Data Protection Office.
6. Personal data of the Promotion Participants will be stored for the period in which complaints can be filed, and in the case of a complaint – for the time necessary to process the complaint and until the statute of limitations for claims expires.
7. Providing personal data is voluntary, but it is a **necessary condition** for the performance of the sales agreement. Consequently, failure to provide personal data will result in the inability to perform the sales agreement.

VIII. Final Provisions

1. These Regulations are available throughout the duration of the Promotion on the following websites: <https://www.indigo-nails.com/>, <https://www.indigo-nails.com/eu-de/>, <https://www.indigo-nails.co.uk>, and <https://www.indigo-nails.es/>.
2. The Regulations enter into force on the day the Promotion begins.
3. During the Promotion period, order processing times may be extended.
4. By participating in the Promotion, the Participant accepts the rules contained in these Regulations and declares that they have read the rules set out in the Regulations and do not raise any objections in this regard.
5. The Organizer reserves the right to change these Regulations during the Promotion without giving a reason, provided that the rights acquired by Participants before the change will be respected. In particular, the Organizer reserves the right to shorten the duration of the Promotion or to exclude individual items from the Promotion due to exhaustion of stock. The Organizer may make such a decision independently.
