Terms and Conditions of the "Conference Promotion Vol. 17", hereinafter referred to as the "Terms and Conditions"

Preamble

This Promotion and Contest are dedicated to **stylists** – both those running beauty salons, as well as those who perform nail styling as employees of beauty salons or on a mobile basis. By organizing this Promotion and Contest, the Organizer aims to support smaller entrepreneurs who provide nail styling services using INDIGO NAILS brand products, by offering price reductions and material prizes. This applies to both those running beauty salons and those who perform nail styling as employees of beauty salons or on a mobile basis, leveling the playing field for them in the market and enabling them to obtain products necessary for performing nail styling at lower prices during the Promotion or as prizes in the Contest, i.e., without incurring financial outlay.

The Promotion and Contest are **in no way** intended for entrepreneurs who, as part of their business activity, sell cosmetic products, including INDIGO NAILS brand products (distributors, sub-distributors, wholesalers).

The purpose of the Promotion and Contest is **not** for entities professionally engaged in the sale of cosmetic products, including INDIGO NAILS brand products, to participate in the Promotion and Contest, purchase products at lower promotional prices or win prizes, and subsequently sell the products obtained at a cheaper price or as a prize with an even greater profit for their sales-based business activity. The Organizer firmly opposes such actions, and consequences will be drawn against individuals who participate in the Promotion and Contest despite not meeting the conditions for participation.

I. Organizer and Duration of the Competition

- 1. The organizer of the promotional campaign "Conference Promotion vol. 17" (hereinafter: the "Promotion"):
 - a. via the online store https://www.indigo-nails.com/ and https://www.indigo-nails.com/eu-de/ is INDIGO NAILS Limited Liability Company with its registered office in Łódź, at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Commercial Division of the National Court Register (KRS) under number KRS: 0001099337, holding NIP: 7292755541 and REGON: 52831975 (hereinafter: Organizer 1);
 - b. **via the online store** https://www.indigo-nails.co.uk/ is UNITED BEAUTY LIMITED a company under British law, entered into the Companies House register under number 12076727, VAT: GB332687684, with its registered office at: 20-22 Wenlock Road, London, England, N1 7GU (hereinafter: Organizer 2);

- c. via the online store https://www.indigo-nails.es/ is INDIGO NAILS ESPANA SL

 a company under Spanish law, entered into the Registradores de Espana register, in the BARCELONA Register, under number NIF: B10731271, with its registered office at: Calle Gelabert 38, mezzanine 1a, 08029 Barcelona. (hereinafter: Organizer 3).
- 2. The Promotion will last during the Indigo Winter Conference vol. 17, i.e., from November 22, 2025, 10:00 a.m. to November 24, 2025, 9:00 a.m. (Central European Time GMT +1) or until stocks are exhausted or the Promotion is canceled by the Organizer (hereinafter: the duration of the Promotion or the Conference) whichever occurs first, excluding the promotion referred to in section 3 below.
- 3. The "warehouse clearance" promotion, which involves the possibility of purchasing Artista mats at the promotional price indicated in point IV sec. 4 i) of the Regulations, will last from **November 22, 2025, 10:00 a.m.** (Central European Time GMT +1) until stocks are exhausted or the Promotion is canceled by the Organizer.
- 4. Promotions may also be organized by INDIGO NAILS brand distributors on their own in their stationary and online stores participation of the distributor in the Promotion is voluntary.
- 5. Each Organizer is individually responsible for conducting the Promotion, changing its rules, or canceling it.
- 6. The Organizers jointly organize the **Competition for the three highest orders** placed during the Promotion. The Competition is related to participation in the Promotion.

II. General Provisions

- 1. The Promotion and the Contest shall be held in accordance with these Regulations.
- 2. Before participating in the Promotion, the Participant should read the Regulations, in particular the conditions for participation in the Promotion.
- 3. By applying to the Promotion, the Participant confirms that they have read the Regulations, understand its provisions, and accept all rules of the Promotion contained in the Regulations, including consenting to take part in the Contest, which is linked to the organized Promotion.

III. Participation in the Promotion and Contest

- 1. Both a consumer, meaning a natural person performing a legal act on the terms specified in these regulations, which is not directly related to their business or professional activity, as well as an entrepreneur conducting business or professional activity in their own name, may take part in the Promotion and the Contest, subject to paragraph 2.
- 2. Distributors, sub-distributors, wholesalers, as well as persons who list products on a marketplace, may not participate in the Promotion and the Contest the above also applies to persons holding a representative function in the aforementioned entities, as well as partners/shareholders in the aforementioned entities. The exclusion does not apply to entities that are not professionally engaged in the sale of cosmetic products, and whose sales are made

- individually or sporadically, to which the Participant, by accepting the Regulations and participating in the Promotion, consents.
- 3. Should any of the persons mentioned in paragraph 2 above participate in the Promotion, the Organizer has the right to:
 - a. if the subject of the sales contract concluded during the Conference has not been released – withdraw from the sales contract (within 2 months of its conclusion) and not release the subject of the sales contract, OR demand the return of the difference between the price of the products not covered by the Promotion and the price at which the Participant acquired the products under the Promotion, making the release of the subject of sale conditional on the payment of this difference – depending on the Organizer's decision;
 - b. if the subject of the sales contract concluded during the Conference has been released

 withdraw from the sales contract (within 2 months of its conclusion) and demand
 the return of the subject of sale, OR demand the return of the difference between the
 price of the products not covered by the Promotion and the price at which the
 Participant acquired the products under the Promotion depending on the Organizer's
 decision.
- 4. Should any of the persons mentioned in paragraphs 2 or 3 above participate in the Contest and acquire the right to a Prize, the Organizer has the right to:
 - a. if the Prize has not been shipped deprive the participant of the right to the Prize due to the failure to meet the conditions for participation in the Contest, which will be associated with the non-shipment of the Prize;
 - b. if the Prize has been shipped deprive the participant of the right to the Prize due to
 the failure to meet the conditions for participation in the Contest, and consequently
 demand the return of the Prize in kind OR demand the return of the value of the Prize
 depending on the Organizer's decision.
- 4. Furthermore, in each of the cases described in paragraphs 3 and 4 above, the Organizer may seek reimbursement from the participant for logistical costs related to the fulfillment of the order covered by the Promotion and the shipment of the Prize in the Contest.
- 5. The Participant undertakes not to sell the products obtained as a Prize for winning the Contest, under the penalty of the consequences described in paragraphs 3 and 4.

IV. Terms and Conditions of the Promotion

- 1. The Participant takes part in the Promotion by purchasing the products covered by the Promotion from the Organizer during the Promotion period.
- 2. The Promotion and the Contest apply to orders placed during the Promotion period both in Poland and abroad through the stores run by the Organizers, i.e.:

 - b. https://www.indigo-nails.com/eu-de/;
 - c. https://www.indigo-nails.co.uk;
 - d. https://www.indigo-nails.es.
- 3. The delivery rules and territorial scope of deliveries are determined separately by each Organizer.
- 4. The Promotion includes:

- a. A 30% reduction on calendars:
- b. **2+1 on Gel Polishes**, excluding nail bases and tops, which means that three hybrid polishes can be purchased for the price of the two most expensive products;
- c. **2+1 on creams, lotions, H&B Cream in 300 ml capacities**, which means that three products can be purchased for the price of the two most expensive products;
- d. **2+1 on hybrid bases and top coats**, excluding Protein Base, which means that any three hybrid bases and tops can be purchased for the price of the two most expensive products;
- e. **2+1 on Primers in 5 ml and 15 ml capacities**, which means that any three Primers in 5 ml and 15 ml capacities can be purchased for the price of the two most expensive products, with the reservation that in the case of placing an order through the Organizer 1's online stores (i.e., in PL/DE Headquarters) the Promotion covers only the **Acid Free Primer 15 ml** product;
- f. **3+1 on Mousse Gels** (in any capacity), which means that four Mousse Gels can be purchased for the price of the three most expensive products;
- g. **One Whitemin Base 7 ml free of charge** for orders placed for a minimum amount of **110 GBP** (the Participant can receive only 1 piece of Whitemin Base 7 ml free of charge with each order);
- h. Artista pads (Manicure Handpad Set higher version and Manicure Handpad Set lower version) at the price of 69 PLN / 16 EUR / 18.60 USD / 13.80 GBP (the price depends on which of the Organizers' online stores the Participant purchases the products);
- Matt Finish Powder 59 mm Hedonista + Pocket Slim brush set at the price of 120 PLN / 31.60 EUR / 36.70 USD / 26.90 GBP for the entire set (the price depends on which of the Organizers' online stores the Participant purchases the products);
- j. **Brush sets at promotional prices** the list and composition of the sets are in Appendix No. 1 to these Regulations;
- k. Cosmetics sets at promotional prices the list and composition of the sets are in Appendix No. 2 to these Regulations.
- 5. The Organizers reserve that the assortment of products covered by the Promotion may differ depending on the Organizer from whom the Participant purchases these products.
- 6. New products are excluded from the Promotion, i.e., products from the new collection of hybrid polishes (Gel Polish) and new home spa products (new SPA fragrances).
- 7. Promotions do not combine.
- 8. The Promotions will be calculated automatically after adding the products to the basket.

V. Contest Terms and Conditions

1. Within two weeks of the Promotion ending, the Organizers will jointly select and rank the three orders with the highest value placed during the Promotion period. The competition will consider orders placed via the following online stores: https://www.indigo-nails.com/; https://www.indigo-nails.com/; https://www.indigo-nails.co.uk; https://www.indigo-nails.co.uk; https://www.indigo-nails.es. Participants who placed the 3 orders with the highest value will receive a Prize (hereinafter: Winners). Depending on their place in the ranking, the Prize takes the form of:

- a. I place Voucher for 350 GBP;
- b. II place Voucher for 200 GBP;
- c. III place Voucher for 100 GBP.
- 2. The Vouchers referred to in sec. 1 will be valid indefinitely.
- 3. The Competition will be resolved, and the Organizers will announce the profile names of the Winners on the Instagram platform within one month of the Conference the announcement will be made on the Instagram profile of each of the Organizers.
- 4. For the purpose of evaluating the order with the highest value, the value of orders placed by the Participant through the online stores will be calculated as follows:
 - a. https://www.indigo-nails.co.uk, in order to standardize the transaction value for the purpose of the Organizers conducting a joint Competition, will be converted from British pounds sterling to Polish złoty, according to the average NBP exchange rate on the day the order was placed;
 - b. https://www.indigo-nails.es/ in order to standardize the transaction value for the purpose of the Organizers conducting a joint Competition, will be converted from euro to Polish złoty, according to the average NBP exchange rate on the day the order was placed.
- 5. The Winners will be informed about the award of the prize by the Organizer from whom they purchased the products, via e-mail message.
- 6. The Winner is obliged to notify the Organizer from whom they received the e-mail message specified in sec. 5 above, of the shipping details for the Prize within 7 days from the date of notification of the Prize award.
- 7. The Prize is handed over to the Winner by the Organizer from whom they placed the order included in the ranking.
- 8. The Prize is not exchangeable for a cash equivalent.
- 9. The Winner may waive the Prize; failure to provide shipping details within 7 days from the date of notification of the Prize award is equivalent to waiving the Prize.

VI. Shipping Costs and Customs Duties

- 1. In the case of orders fulfilled outside:
 - a. the territory of the Republic of Poland and the territory of the Federal Republic of Germany (in the case of purchases made from Organizer 1);
 - b. the territory of the United Kingdom (in the case of purchases made from Organizer 2):
 - c. the territory of Spain (in the case of purchases made from Organizer 3);

The Participant shall bear the cost of shipping the order and any potential customs duties.

2. If a Prize is awarded to a Participant from outside the territory of the Republic of Poland, the Federal Republic of Germany, the United Kingdom, or Spain, the Participant shall bear the cost of shipping the Prize and related customs duties.

VII. Withdrawal from the Sales Agreement and Complaints

- 1. If universally applicable law grants the Participant the right to withdraw from the sales agreement and return products, the return of products purchased in the Promotion is possible only insofar as it constitutes an entire set of new and unused items purchased in the Promotion.
- All complaints regarding the manner in which the Promotion or the Contest was conducted should be submitted by Participants via email to the Organizer from whom they placed the order.
- 3. In the case of the Promotion organized by:
 - a. Organizer 1 complaints shall be submitted to the address: konferencja@indigo-nails.com;
 - b. Organizer 2 complaints shall be submitted to the address: customerservice@indigo-nails.co.uk;
 - c. Organizer 3 complaints shall be submitted to the address: quejas@indigo-nails.es.
- 4. In the case of the Contest, complaints should be submitted to the Organizer from whom the Participant purchased the products during the Promotion period.
- 5. The complaint should contain the annotation: "Conference Promotion vol. 17".
- 6. Complaints regarding the Promotion may be submitted throughout the duration of the Promotion, and up to **14 days** from the date of issuing the products that are the subject of the sales agreement concluded within the framework of the Promotion.
- 7. Complaints regarding the Contest may be submitted for a period of **14 days** from the selection of the Winners, and in the case of Winners, within **14 days** from the date of receiving the Prize.
- 8. The complaint should contain the following details of the person submitting the complaint: first name, last name and exact address, as well as a precise description and reason for the complaint, and the claim made by the person submitting the complaint.
- 9. Complaints submitted after the deadline or not containing the information referred to in paragraph 7 will not be considered. The date of sending the complaint shall be deemed to be:
 - a. in the case of complaints sent by post the date of the postal stamp on the shipment containing the complaint;
 - b. in the case of complaints sent electronically the date the Organizer confirms receipt of the email.
- 10. Complaints will be processed promptly, but no later than within **14 days** from the date of their receipt by the Organizer.

VIII. Data Protection

- 1. The **Controller** of the personal data of the Promotion and Contest Participants is the Organizer from whom the Participant purchased products under the Promotion.
- 2. Personal data collected in connection with the Promotion will be processed for the purpose of carrying out the sales contract, for accounting purposes, as well as for the purpose of pursuing claims and defending against claims arising from the Sales Contract based on the **legitimate legal interest of the Controller**, which is the pursuit and defense of claims. Personal data is also collected for the purpose of carrying out the Contest and sending the Prize based on the **legitimate legal interest of the Organizer**, which is conducting the Contest.

- 3. Participants' personal data may be disclosed to entities supporting the Organizer in the implementation of the Promotion, including but not limited to marketing agencies, courier companies, Postal Operator, law firms, and accounting offices.
- 4. In connection with the processing of personal data by the Organizer, Participants have the following rights:
 - a. the right to access the data and the right to request its rectification, erasure, or restriction of processing;
 - b. the right to data portability of the provided personal data to another controller;
 - c. the right to object to data processing.
- 5. Participants also have the right to lodge a complaint with the competent supervisory authority.
- 6. The personal data of the Promotion Participants will be stored for the period during which it will be possible to submit complaints, and in the case of a complaint for the time necessary to consider the complaint, until the claims become time-barred.
- 7. Providing personal data is voluntary, but it is a necessary condition for the implementation of the sales contract. Therefore, the consequence of not providing personal data will be the inability to carry out the sales contract.
- 8. Personal data will not be subject to profiling.
- 9. Personal data will not be transferred outside the EEA or to an international organization.

IX. Final Provisions

- 1. These Regulations are available throughout the duration of the Promotion on the Organizers' websites: https://www.indigo-nails.com/eu-de/; https://www.indigo-nails.com/eu-de/; https://www.indigo-nails.co.uk.
- 2. The Regulations enter into force on the date the Promotion begins.
- 3. During the Promotion period, the order fulfillment time may be extended.
- 4. By participating in the Promotion and Contest, the Participant accepts the rules contained in these Regulations and declares that they have read the rules set out in the Regulations and raise no objections in this regard.
- 5. The Organizers reserve the right to change these Regulations during the Promotion period, without giving a reason, subject to the condition that the rights acquired by the Participants before the change is made will be respected. In particular, the Organizers reserve the right to shorten the duration of the Promotion or to exclude specific items from the Promotion due to stock depletion.
