

**TERMS AND CONDITIONS OF THE "Discount code after the conference vol. 18"
PROMOTION
(hereinafter referred to as the "Terms and Conditions").**

Preamble

This Promotion is dedicated to stylists – both those running beauty salons and those who perform nail styling as employees of beauty salons or as mobile services.

By organizing this Promotion, the Organizer intends to support smaller entrepreneurs who provide nail styling services using INDIGO NAILS products, including those running beauty salons as well as those providing nail styling services as employees of beauty salons or as mobile services.

Under no circumstances is the Promotion intended for entrepreneurs whose business activities include the sale of cosmetic products, including INDIGO NAILS products (distributors, sub-distributors, wholesalers).

The purpose of the Promotion is not for entities professionally engaged in the sale of cosmetic products, including INDIGO NAILS products, to participate in the Promotion, purchase products at lower promotional prices, and subsequently sell the products obtained at a lower price with an even higher profit for their sales business. The Organizer is firmly opposed to such actions, and consequences will be pursued against individuals who participate in the Promotion despite not meeting the eligibility criteria.

I. Organizer and Duration of the Promotion

1. The Organizer of the "**Post-Conference Discount Code vol. 18**" Promotion (hereinafter: the "Promotion"):
 - a) via the online stores <https://www.indigo-nails.com/> and <https://www.indigo-nails.com/eu-de/> is **Indigo Nails Sp. z o.o.** with its registered office in Łódź at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Commercial Division of the National Court Register (KRS) under number: 0001099337, REGON: 528319750, NIP: 7292755541, BDO: 000643230, with a share capital of 10,100,000.00 PLN (hereinafter: **Organizer 1**);
 - b) via the online store <https://www.indigo-nails.co.uk> is **UNITED BEAUTY LIMITED** – a company incorporated under British law, entered into the Companies House register under number 12076727, VAT: GB332687684, with its registered office at: 20-22 Wenlock Road, London, England, N1 7GU (hereinafter: **Organizer 2**);
 - c) via the online store <https://www.indigo-nails.es/> is **INDIGO NAILS ESPANA SL** – a company incorporated under Spanish law, entered into the Registradores de Espana register, BARCELONA Registry, under NIF number: B10731271, with its registered office at: Calle Gelabert 38, mezzanine 1ª, 08029 Barcelona (hereinafter: **Organizer 3**).
2. The Promotion shall run from **March 9, 2026, 8:00 AM** until **March 31, 2026, 11:59 PM** (Central European Time GMT +1), or until stocks last, or until the Promotion is canceled by the Organizer (hereinafter: **Promotion Period**) – whichever occurs first.
3. Each Organizer is separately responsible for conducting the Promotion, amending its rules, or canceling it.

II. General Provisions

1. The Promotion shall be conducted in accordance with these Terms and Conditions.

2. Prior to entering the Promotion, the Participant should read these Terms and Conditions, in particular the eligibility criteria and conditions for participation.
3. By entering the Promotion, the Participant confirms that they have read the Terms and Conditions, understand their provisions, and accept all rules of the Promotion contained herein.

III. Participation in the Promotion

1. The Promotion is open to both **consumers** (natural persons performing a legal act under the terms of these Regulations not directly related to their business or professional activity) and **entrepreneurs** conducting business or professional activity in their own name, subject to paragraph 2.
2. Distributors and sub-distributors of nail styling products, wholesalers, and persons listing products on marketplaces are **excluded from participating** in the Promotion. This exclusion also applies to persons acting in a representative capacity for the aforementioned entities, as well as their partners. The exclusion does not apply to entities that do not professionally trade in cosmetic products and perform sales only individually or sporadically, to which the Participant agrees by accepting the Regulations and participating in the Promotion.
3. In the event that any of the persons mentioned in paragraph 2 participate in the Promotion, or in the event that a Participant intends the products purchased in the Promotion for resale, the Organizer shall have the right to:
 - a) **If the subject of the sales agreement concluded during the Promotion has not yet been delivered:** withdraw from the sales agreement (within 2 months of its conclusion) and withhold delivery, or demand the difference between the non-promotional price of the products and the promotional price paid by the Participant, conditioning the delivery on the payment of said difference – at the Organizer's discretion;
 - b) **If the subject of the sales agreement concluded during the Promotion has already been delivered:** withdraw from the sales agreement (within 2 months of its conclusion) and demand the return of the items, or demand the difference between the non-promotional price of the products and the promotional price paid by the Participant – at the Organizer's discretion.
4. Furthermore, in each of the cases described in paragraph 3, the Organizer may claim from the Participant the reimbursement of **logistics costs** related to the fulfillment of the promotional order in the amount of **€3.20** for each item included in the order.

IV. Promotion Conditions

1. A Participant takes part in the Promotion by placing an order during its term in the online store of any of the Organizers, i.e., at the following addresses: <https://www.indigo-nails.com/>, <https://www.indigo-nails.com/eu-de/>, <https://www.indigo-nails.co.uk/>, and <https://www.indigo-nails.es/>.
2. The Promotion applies to orders placed during the Promotion period without territorial restrictions, subject to the territorial delivery conditions applicable to the Organizer.
3. The Promotion consists of the following: during the Promotion period, every person who participated in the "Konferencja dla stylistek vol. 18" organized on **March 7, 2026** (hereinafter: the Conference), shall receive a **15% discount code** for selected spring products listed in Appendix No. 1.
4. The discount code will be made available to event participants after the conclusion of the Conference via the e-mail address used to register for the event. The code may be used by a single user only once and cannot be combined with other promotions.
5. During the Promotion, the gross retail price of the **gel polishes** listed in the appendix, after

- applying the discount code, is reduced to **33.14 PLN / 8.41 EUR / 7.23 GBP** gross per unit.
6. During the Promotion, the gross retail price of "**Spring 01**" **self-adhesive nail stickers**, after applying the discount code, is reduced to **12.67 PLN / 3.32 EUR / 2.81 GBP** gross per unit.
 7. During the Promotion, the gross retail price of the **stamping plates** listed in the appendix, after applying the discount code, is reduced to **33.15 PLN / 8.59 EUR / 7.23 GBP** gross per unit.
 8. During the Promotion, the gross retail price of the **Gel Polish hybrid lacquers** listed in the appendix, after applying the discount code, is reduced to **33.14 PLN / 8.42 EUR / 7.23 GBP** gross per unit.
 9. During the Promotion, the gross retail price of the **dried flowers** listed in the appendix, after applying the discount code, is reduced to **8.50 PLN / 2.13 EUR / 1.70 GBP** gross per unit.
 10. During the Promotion, the gross retail price of the **nail bases** listed in the appendix, after applying the discount code, is reduced to **36.54 PLN / 9.27 EUR / 7.99 GBP** gross per unit.
 11. The Organizers reserve the right that the assortment of products covered by the Promotion may vary depending on the Organizer from whom the Participant purchases the products.
 12. Participation in the Promotion is voluntary.
 13. The discount will be applied automatically after entering the discount code.

V. Withdrawal from the Sales Agreement

In the event that generally applicable laws grant the Participant the right to withdraw from the sales agreement and return the products, the return of products purchased under the Promotion is possible only if it constitutes the **entire set of new and unused items** purchased during the Promotion.

VI. Complaints

1. Any complaints regarding the conduct of the Promotion should be submitted by Participants via email to the Organizer with whom the order was placed.
2. In the case of a Promotion organized by:
 - a) **Organizer 1** – complaints shall be submitted to the address: reklamacje@indigo-nails.com or by post to the Organizer's registered office address provided in Section I of the Regulations.
 - b) **Organizer 2** – complaints shall be submitted to the address: customerservice@indigo-nails.co.uk
 - c) **Organizer 3** – complaints shall be submitted to the address: quejas@indigo-nails.es
3. The complaint should include a reference note with the name of the promotion.
4. Complaints may be submitted throughout the duration of the Promotion, as well as up to **14 days** from the date of delivery of the products subject to the sales agreement concluded under the Promotion.
5. The complaint should include the following details of the person making the claim: first name, last name, and exact address, as well as a detailed description and reason for the complaint, and the claimant's request.
6. Complaints submitted after the deadline or those not containing the information referred to in paragraph 5 will not be considered.
7. Complaints will be processed promptly, but no later than within **30 days** from the date of their receipt by the Organizer.

VII. Personal Data Protection

1. The **Controller** of the Promotion Participants' personal data is the Organizer.
2. Personal data collected in connection with the Promotion will be processed for the purpose of performing the sales contract, for accounting and bookkeeping purposes, as well as for the establishment, exercise, or defense of legal claims arising from the Sales Contract—based on the **legitimate legal interest** of the Controller, which is the pursuit and defense of claims.
3. Participants' personal data may be disclosed to entities supporting the Organizer in the execution of the Promotion, including in particular: marketing agencies, courier companies, the Postal Operator, law firms, and accounting offices.
4. In connection with the processing of personal data by the Organizer, Participants are entitled to the following rights:
 - a) the right to access the data and the right to request its rectification, erasure, or restriction of processing;
 - b) the right to data portability (transferring provided personal data to another controller);
 - c) the right to object to the processing of data.
5. Participants also have the right to **lodge a complaint** with the President of the Personal Data Protection Office (PUODO).
6. Personal data of the Promotion Participants will be stored for the period during which complaints may be submitted, and in the event of a complaint—for the time necessary to resolve it, until the **statute of limitations** for claims expires.
7. Providing personal data is voluntary; however, it is a **necessary condition** for the performance of the sales contract. Consequently, failure to provide personal data will result in the inability to execute the sales contract.

VIII. Final Provisions

1. These Terms and Conditions are available throughout the duration of the Promotion on the following websites: <https://www.indigo-nails.com/>, <https://www.indigo-nails.com/eu-de/>, <https://www.indigo-nails.co.uk/>, and <https://www.indigo-nails.es/>.
2. The Terms and Conditions shall come into force on the start date of the Promotion.
3. During the Promotion period, order processing times may be extended.
4. By participating in the Promotion, the Participant accepts the rules contained in these Terms and Conditions and declares that they have read the rules set forth herein and raise no objections in this regard.
5. The Organizer reserves the right to amend these Terms and Conditions during the Promotion without stating a reason, provided that rights acquired by Participants prior to the change are respected. In particular, the Organizer reserves the right to shorten the duration of the Promotion.
