

TERMS AND CONDITIONS OF THE "Conference Promotion vol.18" PROMOTION

(hereinafter referred to as the "Terms and Conditions")

Preamble

This Promotion and Contest are dedicated to stylists – both those running beauty salons and those providing nail styling services as salon employees or mobile stylists. By organizing this Promotion and Contest, the Organizer aims to support smaller entrepreneurs who provide nail styling services using INDIGO NAILS products through price reductions and in-kind prizes. This applies to salon owners, salon employees, and mobile stylists alike, aiming to level the playing field and enable them to obtain essential nail styling products at lower promotional prices or as contest prizes (i.e., without financial expenditure).

Under no circumstances are the Promotion and Contest intended for entrepreneurs who sell cosmetic products, including INDIGO NAILS products, as part of their business activities (distributors, sub-distributors, wholesalers).

The purpose of the Promotion and Contest is not for entities professionally engaged in the sale of cosmetic products, including INDIGO NAILS products, to participate in the Promotion and Contest, purchase products at lower promotional prices, or win prizes, only to subsequently sell the products obtained at a lower price or as a prize for an even greater profit within their retail business. The Organizer is firmly opposed to such practices, and consequences will be enforced against individuals who participate in the Promotion and Contest despite not meeting the eligibility criteria.

I. Organizer and Duration of the Contest

1. The organizers of the promotional campaign "Conference Promotion vol. 18" (hereinafter: the "**Promotion**"):

- **a.** via the online stores <https://www.indigo-nails.com/> and <https://www.indigo-nails.com/eu-de/> is **INDIGO NAILS spółka z ograniczoną odpowiedzialnością** with its registered office in Łódź, at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Commercial Division of the National Court Register under KRS number: 0001099337, NIP: 7292755541, and REGON: 52831975 (hereinafter: **Organizer 1**);
- **b.** via the online store <https://www.indigo-nails.co.uk/> is **UNITED BEAUTY LIMITED** – a company incorporated under British law, entered into the Companies House register under number 12076727, VAT: GB332687684, with its registered office at: 20-22 Wenlock Road, London, England, N1 7GU (hereinafter: **Organizer 2**);
- **c.** via the online store <https://www.indigo-nails.es/> is **INDIGO NAILS ESPANA SL** – a company incorporated under Spanish law, entered into the Registradores de Espana register, in the BARCELONA Register, under NIF: B10731271, with its registered office at: Calle Gelabert 38, mezzanine 1ª, 08029 Barcelona (hereinafter: **Organizer 3**).

2. The Promotion will run during the **INDIGO NAILS Conference vol. 18**, i.e., from **March 7, 2026, 9:00 AM to March 9, 2026, 9:00 AM** (Central European Time GMT +1), or until stocks last, or until the Promotion is cancelled by the Organizer (hereinafter: **Promotion Period** or **Conference**) – whichever occurs first.

3. Promotions may also be organized by INDIGO NAILS brand distributors independently in their physical and online stores – a distributor's participation in the Promotion is voluntary.
4. Each Organizer is separately responsible for conducting the Promotion, changing its rules, or cancelling it.
5. The Organizers are jointly organizing a Contest for the three highest orders placed during the Promotion. The Contest is related to participation in the Promotion.

II. General Provisions

1. The Promotion and the Contest shall be conducted in accordance with these Terms and Conditions.
2. Prior to participating in the Promotion, the Participant should read these Terms and Conditions, in particular the eligibility requirements and conditions for participation.
3. By entering the Promotion, the Participant confirms that they have read the Terms and Conditions, understand their provisions, and accept all rules of the Promotion contained therein, including giving consent to participate in the Contest associated with the organized Promotion.

III. Participation in the Promotion and the Competition

1. Both a **consumer** (a natural person performing a legal act under the terms specified in these Terms and Conditions, not directly related to their business or professional activity) and an **entrepreneur** conducting business or professional activity in their own name may participate in the Promotion and the Competition, subject to section 2.
2. Distributors, sub-distributors, wholesalers, and persons listing products on marketplaces are **excluded** from participating in the Promotion and the Competition. This exclusion also applies to persons acting in a representative capacity for the aforementioned entities, as well as their partners/shareholders. This exclusion does not apply to entities that do not professionally trade in cosmetic products and perform sales only individually or occasionally, to which the Participant agrees by accepting the Terms and Conditions and participating in the Promotion.
3. In the event that any of the persons mentioned in section 2 above participate in the Promotion, the Organizer shall have the right:
 - a. if the subject of the sales agreement concluded during the Conference has not yet been delivered – to **withdraw from the sales agreement** (within 2 months of its conclusion) and withhold delivery, or to demand payment of the difference between the non-promotional price and the price at which the Participant purchased the products under the Promotion, conditioning the delivery on the payment of said difference – at the Organizer's discretion;
 - b. if the subject of the sales agreement concluded during the Conference has already been delivered – to **withdraw from the sales agreement** (within 2 months of its conclusion) and demand the return of the products, or to demand a refund of the difference between the non-promotional price and the price at which the Participant purchased the products under the Promotion – at the Organizer's discretion.
4. In the event that any of the persons mentioned in sections 2 or 3 above participate in the Competition and acquire the right to a Prize, the Organizer shall have the right:
 - a. if the Prize has not been dispatched – to **forfeit the participant's right to the Prize** due to failure to meet the eligibility criteria, resulting in the non-shipment of the Prize;
 - b. if the Prize has been dispatched – to forfeit the participant's right to the Prize due to failure to meet

the eligibility criteria, and consequently, to **demand the return of the Prize in kind** or the reimbursement of the Prize's value – at the Organizer's discretion.

4. Furthermore, in each of the cases described in sections 3 and 4 above, the Organizer may seek **reimbursement of logistics costs** related to the fulfillment of the promotional order and the dispatch of the Competition Prize.

5. The Participant undertakes **not to resell products** obtained as a Prize for winning the Competition, under penalty of the consequences described in sections 3 and 4.

IV. Terms and Conditions of the Promotion

1. A Participant takes part in the Promotion by purchasing products covered by the Promotion from the Organizer during the Promotion Period.

2. The Promotion and the Contest apply to orders placed during the Promotion Period both in Poland and abroad via stores operated by the Organizers, i.e.:

3. Each Organizer determines delivery rules and the territorial scope of deliveries separately.

4. The Promotion includes:

a. A **20% discount** on the Small Set – the list and composition of the set are included in Appendix No. 1 to these Regulations;

b. A **35% discount** on the Medium Set – the list and composition of the set are included in Appendix No. 2 to these Regulations;

c. A **10% discount** on products from the "UV gels" category;

d. **1+1 on Argan Oils**, which means that any two argan oils can be purchased for the price of one product. This promotion cannot be combined with the "Indigo Home SPA in Your Salon" promotion.

e. **3+1 on Gel Polishes** (excluding bases and tops), which means that any four gel polishes can be purchased for the price of the three most expensive products. This promotion can be combined with the -15% discount on gel polishes;

f. **2+1 on 300 ml hand & body creams and lotions**, which means that any three 300 ml hand & body creams and lotions can be purchased for the price of the two most expensive products.

g. A **50% discount** on Full Cover Tips;

h. A discount on white and transparent nail art tips, which will be available for **9 PLN / 2.4 EUR / 2 GBP / 2.8 USD gross**;

i. **The Hedonista Compact Set**, consisting of Face Bronzing Medium 59 mm or Face Bronzing Light 59 mm cream bronzer + Flawless Finish brush for **135.00 PLN / 35.50 EUR / 30.30 GBP / 41.20 USD gross**;

j. **Five Confetti nail dusts** (one of each type) as a gift for every person who ordered a Small Set or a Medium Set during the Promotion;

k. A **20% discount** on 140 ml Body Oil Shower products, which will be available for **31.20 PLN / 8.24 EUR / 7.04 GBP / 9.52 USD** – the list of products participating in the Promotion is included in Appendix No. 3 to these Regulations;

l. A **5% discount** on Pedicure Nippers – Extra Long Blade, which will be available for **90.25 PLN / 23.75 EUR / 20.24 GBP / 27.55 USD gross**;

m. **Zlotyslaw Gel Polish**, which conference participants will be able to purchase for **0.01 PLN / 0.01 EUR / 0.01 USD / 0.01 GBP gross**, after receiving an e-mail notification regarding the limited quantity available. The offer is on a "first come, first served" basis and does not guarantee all participants the opportunity to purchase at the promotional price;

n. **Limited sale of the Drama Queen canvas bag**, released in a run of 100 units, which can only be purchased during the Promotion for **30 PLN / 7.90 EUR / 6.70 GBP / 9.20 USD gross**.

5. The Organizers reserve the right that the assortment of products covered by the Promotion may vary depending on the Organizer from whom the Participant purchases the products.

6. Promotions cannot be combined.

7. Promotions will be applied automatically after adding products to the cart.

V. Competition Terms and Conditions

1. Within two weeks of the Promotion's end, the Organizers will jointly select the three highest-value orders placed during the Promotion period and rank them. The competition will consider orders placed through the following online stores: <https://www.indigo-nails.com/>; <https://www.indigo-nails.com/eu-de/>; <https://www.indigo-nails.co.uk/>; <https://www.indigo-nails.es/>. The Participants who placed the three highest-value orders shall receive a Prize (hereinafter: **the Winners**). Depending on their rank, the Prize shall consist of:

a. 1st Place – A voucher worth 1500 PLN / 350 EUR / 305 GBP;

b. 2nd Place – A voucher worth 1000 PLN / 235 EUR / 200 GBP;

c. 3rd Place – A voucher worth 500 PLN / 115 EUR / 100 GBP.

2. The vouchers referred to in section 1 may be redeemed without an expiration date.

3. The competition results will be determined, and the Organizers will announce the Winners' profile names on Instagram within one month of the Conference – the announcement will be made on each Organizer's Instagram profile.

4. For the purpose of evaluating the highest-value orders and standardizing transaction values for the joint Competition, orders placed by Participants via online stores will be calculated as follows:

a. <https://www.indigo-nails.co.uk/>: values will be converted from British Pounds (GBP) to Polish Zloty (PLN) according to the average NBP (National Bank of Poland) exchange rate from the date the order was placed;

b. <https://www.indigo-nails.com/eu-de/> and <https://www.indigo-nails.es/>: values will be converted from Euro (EUR) to Polish Zloty (PLN) according to the average NBP exchange rate from the date the order was placed.

5. Winners will be notified of the prize award via email by the Organizer from whom they purchased the products.

6. The Winner is obliged to provide the shipping details for the Prize to the Organizer from whom they received the email notification (specified in section 5 above) within 7 days of the notification date.

7. The Prize shall be delivered to the Winner by the Organizer with whom the ranked order was placed.

8. The Prize is not exchangeable for a cash equivalent.

9. A Winner may waive the Prize; failure to provide shipping details within 7 days of the notification date is equivalent to waiving the Prize.

VI. Shipping Costs and Customs Duties

1. In the case of orders fulfilled outside:

a. the territory of the Republic of Poland and the territory of the Federal Republic of Germany (for purchases made from Organizer 1);

b. the territory of the United Kingdom (for purchases made from Organizer 2);

c. the territory of Spain (for purchases made from Organizer 3); the Participant shall bear the cost of shipping the order and any applicable customs duties.

2. In the event that a Prize is awarded to a Participant from outside the territory of the Republic of Poland, the Federal Republic of Germany, the United Kingdom, or Spain, the Participant shall bear the cost of shipping the Prize and any associated customs duties.

VII. Withdrawal from the Sales Agreement and Complaints

1. In the event that generally applicable laws grant the Participant the right to withdraw from the sales agreement and return the products, the return of products purchased within the Promotion is possible only if it constitutes a **complete set of new and unused items** purchased in the Promotion.

2. Any complaints regarding the conduct of the Promotion or the Contest should be submitted by Participants via **email** to the Organizer with whom the order was placed.

3. In the case of a Promotion organized by:

a. Organizer 1 – complaints shall be submitted to: konferencja@indigo-nails.com;

b. Organizer 2 – complaints shall be submitted to: customerservice@indigo-nails.co.uk;

c. Organizer 3 – complaints shall be submitted to: quejas@indigo-nails.es.

4. In the case of the Contest – complaints should be submitted to the Organizer from whom the Participant purchased the products during the Promotion period.

5. The complaint should include the following reference: "**Conference Promotion vol. 18**".

6. Complaints regarding the Promotion may be submitted throughout the duration of the Promotion, as well as up to **14 days** from the date of delivery of the products subject to the sales agreement concluded under the Promotion.

7. Complaints regarding the Contest may be submitted for a period of **14 days** from the selection of the Winners, and in the case of Winners – within **14 days** from the date of receipt of the Prize.

8. The complaint should contain the following data of the person filing the complaint: first name, last name, and exact address, as well as a detailed description and reason for the complaint, and the claimant's request.

Complaints submitted after the deadline or not containing the information referred to in paragraph 7 will not be considered. The date of filing the complaint is considered to be:

a. in the case of complaints sent by post – the date of the postmark on the package containing the complaint;

b. in the case of complaints sent electronically – the date of confirmation of receipt of the email by the Organizer.

10. Complaints will be considered immediately, but no later than within **14 days** from the date of their receipt by the Organizer.

VIII. Personal Data Protection

1. The **Controller** of the Promotion and Contest Participants' personal data is the Organizer from whom the Participant purchased products under the Promotion.
2. Personal data collected in connection with the Promotion will be processed for the purpose of performing the sales contract, for accounting and bookkeeping purposes, as well as for the establishment, exercise, or defense of legal claims arising from the Sales Contract—based on the **legitimate legal interest** of the Controller, which is the pursuit and defense of claims. Personal data is also collected for the purpose of conducting the Contest and delivering the Prize—based on the Organizer's legitimate legal interest in conducting the Contest.
3. Participants' personal data may be disclosed to entities supporting the Organizer in the implementation of the Promotion, including, in particular, marketing agencies, courier companies, the Postal Operator, law firms, and accounting offices.
4. In connection with the processing of personal data by the Organizer, Participants are entitled to the following rights:
 - a. the right of access to data and the right to request its rectification, erasure, or restriction of processing;
 - b. the right to data portability (transferring the provided data to another controller);
 - c. the right to object to the processing of data.
5. Participants also have the right to lodge a complaint with the competent supervisory authority.
6. Promotion Participants' personal data will be stored for the period during which complaints may be submitted, and in the case of a complaint—for the time necessary to resolve the complaint, until the statute of limitations for claims expires.
7. Providing personal data is voluntary; however, it is a **prerequisite** for the performance of the sales contract. Consequently, failure to provide personal data will result in the inability to execute the sales contract.
8. Personal data will not be subject to profiling.
9. Personal data will not be transferred outside the **EEA (European Economic Area)** or to international organizations.

IX. Postanowienia końcowe

1. Niniejszy Regulamin jest dostępny przez cały czas trwania Promocji na stronach internetowych Organizatorów: <https://www.indigo-nails.com/>; <https://www.indigo-nails.com/eu-de/>; <https://www.indigo-nails.es> oraz <https://www.indigo-nails.co.uk>.
2. Regulamin wchodzi w życie w dniu rozpoczęcia Promocji.
3. W okresie trwania Promocji czas realizacji zamówień może zostać wydłużony.
4. Uczestnik biorąc udział w Promocji i Konkursie, akceptuje ich zasady zawarte w niniejszym Regulaminie i oświadcza, że zapoznał się z jej zasadami, określonymi w Regulaminie i nie wnosi w tym zakresie żadnych zastrzeżeń.
5. Organizatorzy zastrzegają sobie prawo do zmiany niniejszego Regulaminu w czasie trwania Promocji, bez podania przyczyny z zastrzeżeniem, że uprawnienia nabyte przez Uczestników przed dokonaniem zmiany będą respektowane. W szczególności Organizatorzy zastrzegają sobie prawo do skrócenia czasu trwania Promocji lub do wyłączenia z Promocji poszczególnych artykułów wskutek

wyczerpania zapasów magazynowych.
