# TERMS AND CONDITIONS Self Leveling Gels Day

### I. General provisions

- 1. We invite you to participate in "Self Leveling Day" (hereinafter: Promotional Meetings), which will be held on-site at the facilities of entities cooperating with Indigo Nails Sp. z o.o. with their registered office in Łódź (93-192) at 14/16 Senatorska Street, entered into the register of entrepreneurs of the National Court Register under the number KRS 0000684415, registration court: District Court for Łódź-Śródmieście in Łódź, 20th Commercial Division of the National Court Register, with REGON (Polish Business Registry Number) 101805889, NIP (Tax Identification Number) 7272792881 (hereinafter: Indigo Nails) and online from December 2, 2022 to December 7, 2022.
- 2. The schedule of Promotional Meetings with information about the Organizer and the platform on which the Online Promotional Meeting will be held is available at the following website: <a href="https://www.indigo-nails.com/blog/self-leveling-gels-day">https://www.indigo-nails.com/blog/self-leveling-gels-day</a>.
- 3. The Organizer should be understood as the Organizer appropriate for the place where the Promotional Meeting was organized, in which the Participant took part.
- 4. Promotional Meetings include the presentation of new products and products from the latest Indigo Nails collection.

## II. Rules for participating in the Promotional Meeting

- 1. Any natural person with full legal capacity may participate in the Promotional Meeting. Persons with limited legal capacity may participate in the Promotional Meeting with the consent of their statutory representative.
- 2. To participate in the Promotional Meeting, it is necessary to submit an application to the Organizer appropriate for the place where the Promotional Meeting is organized and pay the registration fee for participation in the Promotional Meeting in the amount of PLN 50.00 gross (in words: fifty zlotys 00/100).
- 3. Applications should be made by phone or e-mail. The contact details of the Organizers and the registration form are available on the following website: <a href="https://www.indigo-nails.com/en/blog/self-leveling-gels-day">https://www.indigo-nails.com/en/blog/self-leveling-gels-day</a>.
- 4. Payment of the registration fee referred to in sec. 2 should be made via bank transfer to the bank account indicated by the Organizer appropriate for the place where the Promotional Meeting is organized 24 hours before each Promotional Meeting.
- 5. If the Participant does not take part in the Promotional Meeting, the Organizer has the right to keep the registration fee.
- 6. Each Participant will receive the following from the Organizer during each Meeting:
  - Certificate of participation in the Self Leveling Gels Day Promotional Meeting, however, in the case of participation in the online Promotional Meeting, the Participant will receive Certificate of Participation in an electronic version (the certificate will be sent to the Participant's e-mail address provided during registration for the Promotional Meeting);
  - Giftpack with a value of not less than PLN 50 gross (in words: fifty zlotys 00/100).
- 7. A Participant who pays the registration fee, but does not appear at the Meeting, is not entitled to the benefits referred to in item 6.
- 8. Indigo Nails reserves the right to change these Terms and Conditions during the Promotional Meetings, without giving any reason, with the proviso that the rights acquired by the Participants before the change will be respected.

### III. Complaints

- 1. All complaints regarding the Promotional Meetings should be submitted by Participants via e-mail using the Organiser's contact details, which are available on the following website <a href="www.indigo-nails.com">www.indigo-nails.com</a> or by post to the address of the Organizer's office with an inscription: "Self Leveling Gels Day complaint".
- 2. Complaints referred to in sec. 1 can be submitted within 14 days from the end date of the Promotional Meeting.
- 3. The complaint should contain the complainant's data: name, surname and correspondence address, as well as a **detailed description and the reason for the complaint**.
- 4. Complaints will be considered immediately, but not later than within 14 days from the date of their receipt by the Organizer.
- 5. Complaints submitted after the deadline or which do not contain the information referred to in sec. 3 will not be considered. The date of sending a complaint by post is the date on the postmark on the parcel containing the complaint.

### IV. Processing of personal data

- 1. The Controller of the personal data of a Participant in the Promotional Meeting is each time the Organizer appropriate for the place where the Meeting is organized, in which the Participant takes part.
- 2. In the event of participating in the Meeting at the Indigo Nails Headquarters in Łódź on March 19, 2022, the Controller of the participants' personal data is INDIGO NAILS spółka z ograniczoną odpowiedzialnością (limited liability company) with their registered office in Łódź at 14/16 Senatorska Street, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, 20th Commercial Division of the National Court Register under the KRS number: 0000919132, with NIP: 7272792881 and REGON 101805889.

- 4. Personal data is collected for the following purposes:
  - implementation of the Promotional Meeting on the basis of an agreement concluded with the Meeting Participant for the organization of the Promotional Meeting, i.e. Art. 6 (1) (b) of the GDPR.
  - consideration and defence against claims that a Participant of the Promotional Meeting may submit in connection with participation in the Promotional Meeting the basis for processing is the legitimate interest of the Controller, which is the consideration of submitted claims and defence against them, i.e. Article 6 (1) (f) of the GDPR.
  - sending marketing information based on the consent given by the Participant.
- 5. The Controllers will store the personal data of the Participants no longer than 3 months from the date of the Promotional Meeting, and in the event of claims being submitted until they are considered.
- 6. In connection with the processing of personal data by the Controller, Participants have the following rights:
  - the right to access data and the right to request rectification, deletion or limitation of its processing,
  - the right to transfer personal data to another controller,
  - the right to object to data processing for the purpose of considering and defending against claims;
  - the right to withdraw consent to the processing of data for marketing purposes.

- 7. Participants also have the right to lodge a complaint with the President of the Personal Data Protection Office.
- 8. Providing personal data for the purpose of concluding and executing the agreement for the organization of the Promotional Meeting is voluntary. However, providing this data is a necessary condition to participate in the Promotional Meeting. Failure to provide personal data results in the inability to participate in the Promotional Meeting. Providing data for marketing purposes is voluntary, but it is a condition for receiving marketing information.
