RULES OF THE COMPETITION "Holi Hey!"

I. General information

- 1. The organizer of the competition "Holi Hey show us your summer chill" (hereinafter: "Competition") is INDIGO NAILS, a limited liability company based in Łódź, at ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Commercial Division of the National Court Register under the KRS number: 0000919132, with NIP: 7272792881 and REGON 101805889, (hereinafter: Organizer / Indigo Nails) and Indigo Nails partners from whom it is possible to purchase Products covered by the Promotion in accordance with point II para. 2 c), d) and e) (hereinafter "Partner / Partners") of the Regulations (hereinafter: Regulations), however, for a specific Promotion Participant, the Promotion Organizer is always the entity with which the Participant concludes a sales contract.
- 2. Participation in the Competition means that the Participant has read and accepted these Regulations.
- 3. The competition is not a game of chance, a raffle lottery, a mutual bet, a promotional lottery, a game the result of which depends on the case, or any other form provided for in the Gambling Act of 19 November 2009 (i.e. Journal of Laws of 2022 r. item 888).
- 4. The competition will be held in accordance with these Regulations.

II. Conditions for participation in the Competition

- 1. The Competition is open to natural persons (hereinafter: "Participant" or "Participants") who meet the following conditions:
- have full legal capacity;
- reside on the territory of the Republic of Poland;
- have a public account on the Instagram portal;
- the entry into the Competition is conditional upon the Participant having all copyrights to it.
- 2. Employees, including those employed under civil law contracts, the Organizer and other potential entities directly involved in the preparation and conduct of the Competition, as well as members of their immediate families, may not participate in the Competition. Close family members are understood as: ascendants, descendants, persons in an adopted relationship, siblings, spouses, siblings, relatives and relatives.
- 3. Before entering the Competition, the Participant should read the Regulations.

III. Rules for participation in the Competition

- 1. The competition runs from June 2, 2022 at 10:00 (CET +1) to June 16, 2022 at 23:59. (Central European Time GMT +1).
- 2. To take part in the Competition, the Participant should jointly:
- a) within the time stipulated in the regulations, prepare a recording on your Instagram profile in the form of the so-called reels / rolls in which he will show his summer chill;
- b) the recording should not exceed 60 seconds;
- c) share the recording on your Instagram profile and tag it with the following hashtag: #konkursholihey.

IV. Award in the Competition

- 1. The Competition Commission, composed of three persons, will decide on the award of the Prize.
- 2. The prize will be awarded to a total of 8 Participants (hereinafter: the Winners).
- 3. From the films published on Instagram, the Competition Committee will select the best eight recordings that will be characterized by the greatest creativity and ingenuity.
- 4. The Competition Winners will be selected by the Competition Committee only from among persons meeting the conditions specified in these Regulations.
- 5. The results of the Contest will be announced on June 18, 2022 at 2 p.m. on Instagram on the Indigo Nails profile by tagging the Winners in the form of stories videos.
- 6. The prize in the Competition is a Longboard in one of the colors from the HoliHey collection.
- Each Winner will receive the package mentioned in the first sentence as the Prize. [1 Longboard in a random Holi Hey color].
- 7. The winner may not request the prize to be converted into a cash equivalent or any other form of compensation, and may not transfer the right to the prize to a third party.
- 8. The Winner may waive the right to the Prize.
- 9. The prize will be sent by courier to the Winner's address within 14 days from the announcement of the Competition results.
- 10. The Competition Winner will receive the Prize on the condition that the Organizer must send the Organizer via e-mail to the following address: marketing@indigo-nails.com, within 7 days from the moment the Organizer informs about the win, the data necessary to address the parcel containing the Prize.

- 11. If the return message is not sent within the time limit specified in sec. 10 or sending an e-mail containing incorrect or incomplete identification data of the Winner, or not containing consent to the processing of data, the Winner loses the right to the Prize.
- 12. The Organizer has the right to exclude from the Competition Participants who violate these Regulations, as well as Participants who conduct activities contrary to the law or decency, in particular when the post referred to in point III above contains content generally considered offensive, violating or suggesting a violation of the law, morality or good manners, dignity or rights of third parties, including in particular those containing elements related to violence, discrimination, nudity, drugs, alcohol or tobacco, detrimental to religious feelings, as well as commercial responses (advertising), as well as descriptions that otherwise violate applicable law or the Regulations.

V. Complaints

- 1. All complaints regarding the manner of conducting the Competition and the transfer of prizes should be submitted by the Participants by e-mail to the following address: reklamacje@indigo-nails.com or by post to the address of the Organizer's seat provided in point I of the Regulations, with the annotation: "" Holi Hey Competition "Competition complaint". The deadline for submitting the complaint referred to in the first sentence with respect to Competition Participants is 7 days from the date of announcement of the Competition results, and in the case of Winners, this deadline is 7 days from the date of receiving the Prize.
- 2. The complaint should contain the data of the claimant, ie name, surname and exact address, as well as a detailed description and reason for the claim, as well as the claimant's request.
- 3. Complaints submitted after the deadline or which do not contain the information referred to in sec. 2 will not be considered.
- 4. In the case of a complaint submitted in the form of an e-mail, the date of sending the complaint is the date of confirmation of receipt by the Organizer of the e-mail containing the complaint in its content.
- 5. Complaints will be considered immediately, but not later than within 14 days from the date of their receipt by the Organizer.

VI. Personal data protection

- 1. The Organizer is the administrator of the personal data of the Competition Participants.
- 2. Personal data collected in connection with the Competition will be processed in order to implement the Competition and to issue the Prize. The data is processed on the basis of the consent of the Participants, as well as for tax purposes (Article 6 (1) (a) and (c) of the GDPR).
- 3. Participants' personal data may be disclosed to entities supporting the co-administrators in the implementation of the Competition, including in particular marketing agencies, courier companies, and the Polish Post Office.

- 4. In connection with the processing of personal data by the co-administrators, the Participants have the following rights: a) the right to access data and the right to request rectification, deletion or limitation of their processing. b) the right to transfer the provided personal data to another administrator. c) the right to withdraw consent to data processing;
- 5. Participants also have the right to lodge a complaint with the President of the Personal Data Protection Office.
- 6. The personal data of the Competition Participants will be kept for the period in which it will be possible to submit complaints, and in the case of complaints for the time necessary to consider the complaint.
- 7. Providing personal data for the implementation of the Competition is voluntary. Providing these data is, however, a prerequisite for the possibility of the Contest being carried out by the Co-administrators, including, in particular, the transfer of Prizes to the Winners. The consequence of not providing personal data is the inability to receive the Prize from the Organizer.

VII. Final Provisions

- 1. These Regulations are available throughout the duration of the Competition on the website www.indigo-nails.com
- 2. Any disputes related to the interpretation of the Regulations and the implementation of the rights and obligations related to the Competition will be resolved through the complaint procedure described in point V above, and in the absence of a resolution by the competent common court according to the Organiser's seat.
- 3. The Regulations come into force on the day of the Competition commencement.
- 4. The Organizer may at any time change the Rules of Participation in the Competition, about which he will inform the Participants on his official profile on Instagram. In the event of changes to the Regulations, these changes will not infringe the rights already acquired by the Participants.
- 5. The amended version of the regulations is valid from the moment of publication.
- 6. By entering the Competition, the Participant confirms that he has read the Regulations, understands its provisions and accepts all the rules of the Competition contained in the Regulations. Page 3 of 4 "Holi Hey" Contest
- 7. In the event of the obligation referred to in Art. 30 sec. 1 point 2 of the Personal Income Tax Act of July 26, 1991 (i.e. Journal of Laws of 2021, item 1128, as amended), the Organizer will calculate, collect and deliver to the appropriate Office Fiscal flat-rate income tax Appendix 1: "I consent to the processing of my personal data by INDIGO NAILS sp. Z o.o. based in Łódź, in order to issue the Prize in the Competition organized as part of the" Holi Hey Competition "event.
