RULES OF THE SPRINGSECCO COMPETITION "BE INSPIRED BY THE FILM OF SPRINGSECCO CAMPAIGNS"

#### I. General information

- 1. The Organizer of the Competition and the Founder of the Awards in the Competition held as part of the event for the Springsecco Competition "Get inspired by the Springsecco campaign film" (hereinafter the "Competition") is: INDIGO NAILS limited liability company based in Łódź (formerly: Indigo Nails limited liability company limited partnership), at ul. Senatorska 14/16, 93-192 Łódź, entered in the Register of Entrepreneurs of the National Court Register under the KRS number: 0000919132, with NIP: 7272792881, REGON: 101805889, share capital: PLN 12,000,000.00, registration files kept in the District Court for Łódź-Śródmieście in Łódź, 20th Commercial Division of the National Court Register (hereinafter the "Organizer" or "Founder").
- 2. Participation in the Competition requires acceptance of these Regulations.
- 3. The competition is not a game of chance, a raffle lottery, a mutual bet, a promotional lottery, a game whose result depends on the case, or any other form provided for in the Act of 19 November 2009 on gambling (Journal of Laws 2009.201.1540 as amended).
- 4. The competition will be held in accordance with these Regulations (hereinafter "Regulations").

#### II. Conditions for participation in the Competition

- 1. The Competition is open to natural persons (hereinafter: "Participant" or "Participants") who meet the following conditions:
- have full legal capacity;
- reside on the territory of the Republic of Poland;
- have a public account on the Instagram portal;
- the entry into the Competition is conditional upon the Participant having all copyrights to it;
- 2. Employees, including those employed under civil law contracts, the Organizer and other potential entities directly involved in the preparation and conduct of the Competition, as well as members of their immediate families, may not participate in the Competition. Close family members are understood as: ascendants, descendants, persons in an adopted relationship, siblings, spouses, siblings, relatives and relatives.
- 3. Before entering the Competition, the Participant should read the Regulations.

## III. Rules for participation in the Competition

- 1. The competition runs from 04/04/2022 at until 04/15/2022 at 23:59 Polish time.
- 2. To take part in the Competition, the Participant should:
- a) within the time stipulated in the regulations, prepare the styling with Indigo Nails products on the topic: "Springsecco competition get inspired by the Springsecco campaign film", and then take photos of the styling in a full arrangement referring to the theme of the Competition.
- b) the styling should be done on the hand or on a minimum of 5 tips.
- c) share a photo of nail styling on your Instagram profile and tag the photos with the following hashtags: #konkursspringsecco

## IV. Award in the Competition

- 1. The Competition Commission, composed of three persons, will decide on the award of the Prize.
- 2. The prize will be awarded to 5 Participants (hereinafter: the Winners).
- 3. From the published posts on Instagram, the Competition Committee will select the five best works that will be characterized by the greatest creativity and ingenuity of styling, which will consist of nail styling and the arrangement of the photo itself.
- 4. The Competition Winners will be selected by the Competition Committee only from among persons meeting the conditions specified in these Regulations.
- 5. The results of the Contest will be announced on April 18, 2022 at 2 p.m. on the Instagram profile of Indigo Nails by tagging the Winners with stories.
- 6. The prize in the Competition is the Preorder of the Springsecco Collection, a package with: 11 items of Indigo hybrid varnishes (Lux Torpeda, Cold Gold, Tina Platina Materialista, Diamentica, Springsecco, Boom Shakalaka, Pink Bling, Girls Wanna Have Glam, Good Nude, Elegantus) and Springsecco collection stencil. Each winner will receive the above set as a Prize.
- 7. The winner may not request the prize to be converted into a cash equivalent or any other form of compensation, and may not transfer the right to the prize to a third party.
- 8. The Winner may waive the right to the Prize.
- 9. The prize will be sent by courier to the Winner's address within 14 days from the announcement of the Competition results.
- 10. The Competition Winner will receive the Prize on condition that the Organizer sends the data necessary to address the package containing the Prize, and consent to the processing of data in order to receive and implement the Prize, constituting Appendix 1 to these regulations, within 7 days from the moment the Organizer informs about the win.

- 11. If the return message is not sent within the time limit specified in sec. 11 or sending an e-mail containing incorrect or incomplete identification data of the Winner or not containing consent to data processing, the Winner loses the right to the Prize.
- 12. The Organizer has the right to exclude from the Competition Participants who violate these Regulations, as well as Participants who conduct illegal or deceptive activities, in particular when the post referred to in point III above contains content generally considered offensive, violating or suggesting a violation of the law, morality or good manners, dignity or rights of third parties, including in particular those containing elements related to violence, discrimination, nudity, drugs, alcohol or tobacco, harmful to religious feelings, as well as commercial responses (advertising), as well as descriptions that otherwise violate applicable law or the Regulations.

## VI. Personal data protection

- 1. The Organizer is the administrator of the personal data of the Competition Participants.
- 2. Personal data collected in connection with the Competition will be processed in order to implement the Competition and to issue the Prize. The data is processed on the basis of the consent of the Participants, as well as for tax purposes (Article 6 (1) (a) and (c) of the GDPR).
- 3. Participants' personal data may be disclosed to entities supporting the co-administrators in the implementation of the Competition, including in particular marketing agencies, courier companies, and the Polish Post Office.
- 4. In connection with the processing of personal data by the co-administrators, the Participants have the following rights: a) the right to access data and the right to request rectification, deletion or limitation of their processing. b) the right to transfer the provided personal data to another administrator. c) the right to withdraw consent to data processing;
- 5. Participants also have the right to lodge a complaint with the President of the Personal Data Protection Office.
- 6. The personal data of the Competition Participants will be kept for the period in which it will be possible to submit complaints, and in the case of complaints for the time necessary to consider the complaint.
- 7. Providing personal data for the implementation of the Competition is voluntary. Providing these data is, however, a prerequisite for the possibility of the Contest being carried out by the Co-administrators, including, in particular, the transfer of Prizes to the Winners. The consequence of not providing personal data is the inability to receive the Prize from the Organizer.

# **VII. Final Provisions**

- 1. These Regulations are available throughout the duration of the Competition on the website www.indigo-nails.com
- 2. Any disputes related to the interpretation of the Regulations and the implementation of the rights and obligations related to the Competition will be resolved through the complaint procedure described in point V above, and in the event of no resolution by the competent common court.

- 3. The Regulations come into force on the day of the Competition commencement.
- 4. The Organizer may at any time change the Rules of Participation in the Competition, about which he will inform the Participants on his official profile on Instagram. In the event of changes to the Regulations, these changes will not infringe the rights already acquired by the Participants.
- 5. The amended version of the regulations is valid from the moment of publication.
- 6. By entering the Competition, the Participant confirms that he has read the Regulations, understands its provisions and accepts all the rules of the Competition contained in the Regulations. Page 3 of 4 Halloween Competition "Spooky Decorations"
- 7. In the event of the obligation referred to in Art. 30 sec. 1 point 2 of the Personal Income Tax Act of 26 July 1991 (i.e. Journal of Laws 2016.2032 of 2016.12.15), the Organizer will calculate, collect and pay the flat-rate income tax to the appropriate Tax Office before issuing the Award.
