ANNEX dated 1 February 2023. to the Promotion "Indigo Home SPA in Your Salon" running from 24 June 2020.

- **11**. during the Promotion Period, each Participant purchasing between 5 and 10 Shea Elixir Skin Olive with keratin 8ml will purchase them with a 10% discount at a price of PLN 10.80 / EUR 2.52 / GBP 2.34 gross per unit;
- **12**. during the promotion period, each Participant purchasing more than 10 Shea Elixir Skin Olive with keratin 8ml will purchase them with a 15% discount at PLN 10.20/€2.38/£2.21 gross per item;
- **13**. during the promotion period, each Participant purchasing between 5 pcs. and 10 pcs. Protein Serum 8ml, will purchase it with a discount of 10% at the price of PLN 17.10 / EUR 4.23 / GBP 3.60 gross per unit;
- **14.** during the promotion period, each Participant purchasing more than 10 pcs. Protein Serum 8ml, will purchase it with a discount of 15% at the price of PLN 16.15/ EUR 3.99/ GBP 3.40 gross per unit;
- **15**. during the promotion period, each Participant purchasing more than 10 pcs. Body Mist 100 ml, will purchase them with a discount of 10% at the price of 26.10 PLN/6.21 EUR/5.67 GBP gross per unit;
- **16**. during the promotion period, each Participant purchasing more than 10 pcs. Body Mist 100 ml, will purchase them with a discount of 15% at the price of PLN 24.75/5.86 EUR/5.35 GBP gross per unit;
- **17**. during the promotion period, each Participant when purchasing more than 10 pcs. Enzymatic Peeling 150g, will purchase them with a discount of 10% at a price of PLN 40.50 / EUR 9.45 / GBP 8.10 gross per unit;
- **18.**During the promotion period, each Participant with a purchase of more than 10 pcs. Enzymatic Peeling 150g, will purchase them with a discount of 15% at the price of PLN 38.25/ EUR/ 8.92/ GBP 7.65 gross per item;
- 19. During the Promotion, each Participant may place any number of orders;
- **20**. this Promotion does not combine with other promotions for the products listed in items 1-18.
- **21**.Indigo Nails reserves the right to change these Terms and Conditions during the Promotion, without giving any reason, with the proviso that the rights acquired by the Participants before the change shall be respected. In particular, Indigo Nails reserves the right to shorten the duration of the Promotion or to exclude particular items from the Promotion as a result of running out of stock.

- **22**. For any Organizer other than Indigo Nails, the prices indicated in points 1-18 of this section are only suggested prices. Each Participant should make sure before placing an order whether the Promotion is valid with a given Organiser and whether the price for the Promotional products is not lower or higher than indicated in these Terms and Conditions.

1. I. Organiser and duration

- 1. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Commercial Division of the National Court Register under KRS no.: 0000919132, holding tax identification number (NIP): 7272792881 and statistical number (REGON): 101805889, (hereinafter: Indigo Nails) and partners of Indigo Nails at which it is possible to purchase the Products included in the Promotion according to point II para. 2 c), d) and e) of the Terms and Conditions (hereinafter referred to as the "Organiser"), however for a particular Participant in the Promotion the Organiser of the Promotion shall always be the entity with which the Participant enters into a sales agreement. 2.
- **2**. The Promotion shall run from 24 June 2020 from 10:00:00 (GMT +1) until stocks are exhausted or the Promotion is cancelled by the Organiser. (hereinafter: the duration of the Promotion).

II. Terms and conditions of participation in the Promotion

- e. in online shops run by entities listed above;
- f. at sales representatives of the entities mentioned above. 3.
- 2. The Promotion applies to orders placed during the Promotion period both in Poland and abroad.

III. Complaints and returns

1. Any complaints regarding the manner in which the Promotion is conducted shall be submitted by the Participants by email to reklamacje@indigo-nails.com or by post to the

Organiser's registered office address given in point I of the Terms and Conditions, with the annotation: "Indigo Home Spa Promotion", throughout the duration of the Promotion, but no later than 14 days from the date of delivery of the order covered by the Promotion.

- **2.**The complaint shall contain the following data of the person submitting the complaint: first name, surname and exact address, as well as the exact description and reason for the complaint and the claim of the person submitting the complaint.
- **3.** Complaints submitted after the deadline or not containing the information referred to in paragraph shall not be considered. The date of sending the complaint shall be deemed to be:
 - a) in the case of complaints sent by post, the date of the postmark on the parcel containing the complaint;
 - b) in the case of complaints sent by e-mail the date of confirmation of receipt of e-mail by the Organiser.
- **4.** Complaints shall be considered immediately, however, no later than within 14 days of their receipt by the Organiser.
- **5.** In the event that the provisions of common law grant a right of return to the Participant, the return of products purchased in the Promotion shall be possible as long as they constitute a whole set of new and unused items purchased in the Promotion. The return can be made by the customer only to the Organiser within the meaning of point I item 1 of the Terms and Conditions.

IV. Protection of personal data

- **1.** The Administrator of the personal data of the Promotion Participants shall be the Organiser.
- 2. Personal data collected in connection with the Promotion shall be processed for the purpose of order fulfilment, for accounting and bookkeeping purposes, as well as for the investigation of claims and defence against claims arising from the Sales Agreement on the basis of the Administrator's legitimate legal interest in the investigation of claims and defence against claims.

 - a) The right of access to the data and the right to request their rectification, erasure or restriction of their processing;

- **7.** The provision of personal data is voluntary, however, it is a prerequisite for the processing of the order. As a consequence, if you do not provide your personal data, we will not be able to process your order.
- 8. Personal data will not be transferred outside the EEA.
- **9.**Personal data will not be subject to decisions based solely on automated processing of personal data, including profiling.

V. Final Provisions

- 1.These Terms and Conditions shall be available throughout the duration of the Promotion on the website www.indigo-nails.com.
- 2. These Terms and Conditions shall enter into force on the date the Promotion starts.
- 3. During the period of the Promo0on, the delivery time may be extended.
- 4.By participating in the Promotion, the Participant accepts the rules contained in these Terms and Conditions and declares that he/she has familiarised himself/herself with the rules set out in these Terms and Conditions and does not raise any objections in this respect.
