### MOUSSE GEL PROMOTION TERMS AND CONDITIONS

# I. Organiser and duration

- 1. The organiser of the promotional campaign "Mousse Gel Promotion" (hereinafter: "Promotion") is Indigo Nails Ltd. with its registered office in Łódź (93-192) at ul. Senatorska 14/16, entered into the Register of Entrepreneurs of the National Court Register under the number KRS 0000919132, registration court: District Court for Łódź Śródmieście in Łódź, XX Commercial Division of the National Court Register, holding the REGON number 101805889, NIP number 7272792881, where it is possible to purchase Products covered by the Promotion (hereinafter referred to as the "Organiser").
- 2. The Promotion will run from May 25, 2023 at 10:00 am (Central European Time GMT +1) until stocks last (hereinafter: Promotion Period).

#### **II.** Terms of the Promotion

- 1. Both the consumer, i.e. a natural person performing a legal transaction under the conditions set out in these regulations, not directly related to its business or professional activity, as well as an entrepreneur that is a natural person, a legal person and an organisational unit referred to in the Promotion can participate in the Promotion. article 331 1 k.c., conducting business or professional activity on its own behalf (hereinafter: Participant).
- 2. The Participant takes part in the Promotion by placing an order during its validity at:
  - a) the Indigo Nails online store at https://www.indigo-nails.com/;
  - b) official points of sale (Indigo Nails Distributors) who participate in the Promotion, because joining the Promotion through official points of sale is voluntary. The Participant may find out whether a given point of sale is participating in the Promotion by directing a question to each of the official points of sale;
  - c) the Promotion applies to orders placed during the Promotion period both in Poland and abroad.
- 3. The Participant undertakes not to resell the Products covered by the Promotion in any scope, especially as part of the Participant's business activity. In the event of a breach of the above provisions, the Organiser has the right to claim from the Participant the return of the value of the products that the Participant purchased as part of the Promotion, to which the Participant, by accepting the Regulations and taking part in the Promotion, agrees.

## **III.** Rules of the Promotion

- 1. During the promotion period, the Participant has the option to purchase UV MOUSSE GEL (4 ml) for PLN 3/EUR 0.7/GBP 0.6 gross per item.
- 2. The price referred to in section 1 above is charged without necessity
- 3. This promotion cannot be combined with other promotions.
- 4. Indigo Nails reserves the right to amend these Regulations during the Promotion, without giving any reason, provided that the rights acquired by the Participants before the amendment will be respected. In particular, Indigo Nails reserves the right to shorten the duration of the Promotion or to exclude individual items from the Promotion due to the exhaustion of stocks.

#### I. Complaints and returns

- 1. Any complaints regarding the way of conducting the Promotion should be reported by the Participants by e-mail to reklamacje@indigo-nails.com or by post to the address of the Indigo Nails registered office given in point 1 sec. 1 of the Regulations, with the note: "mousse gel promotion" for the entire duration of the Promotion, but not later than 14 days from the date of delivery of the order covered by the Promotion.
- 2. The complaint should contain the following details of the Participant: name, surname and exact

- address, as well as a detailed description and reason for the complaint, and Participant's preferred method of resolvement.
- 3. Complaints submitted after the deadline or not containing the information referred to in paragraph 2 will not be considered. The date of sending the complaint is the date of the postmark on the parcel containing the complaint.
- 4. Complaints will be considered immediately, however, not later than within 14 days from the date of their receipt by Indigo Nails
- 5. If the provisions of generally applicable law grant the Participant the right to return, the return of products purchased in the Promotion is possible as long as it is a whole set of new and unused items purchased in the Promotion. The return may be made by the customer only in relation to the Organiser within the meaning of point I para. 1 of the Regulations.

## V. Personal data protection

- 1. The administrator of the personal data of the Promotion Participants is the Organiser.
- 2. Personal data collected in connection with the Promotion will be processed in order to fulfill the order,
- 3. for accounting purposes, as well as in the scope of pursuing claims and defending against claims arising from the Sales Agreement based on the legitimate legal interest of the Administrator, which is the pursuit of claims and defence against claims.
- 4. Participants' personal data may be disclosed to entities supporting the Organiser in the implementation of the Promotion, including in particular marketing agencies, courier companies, the Polish Post.
- 5. In connection with the processing of personal data by the Organiser, Participants have the following rights:
- 6. the right to access data and the right to request rectification, deletion or limitation of their processing;
- 7. the right to transfer the provided personal data to another administrator;
- 8. the right to object to data processing.
- 9. Participants also have the right to lodge a complaint with the President of the Office for Personal Data Protection.
- 10. The personal data of the Promotion Participants will be stored for the period in which it will be possible to submit complaints, and in the case of complaints for the time necessary to consider the complaint.
- 11. Providing personal data is voluntary, however, it is a necessary condition for the execution of the order. The consequence of not providing personal data will therefore be the inability to complete the order

### VI. Final Provisions

- 1. The Promotion Terms and Conditions are available at the registered office of each Organiser and on their website.
- 2. During the Promotion period, the order processing time may be extended.
- 3. By participating in the Promotion, the Participant accepts the rules contained in these Term and Conditions and declares that they have read the rules set out in the T&Cs and do not raise any objections in this respect.
