Regulations for the Special Offer "Mother's Day at Indigo" 2022

I. Organizer and duration

- 1. The organizer of the special offer "Mother's Day at Indigo" (hereinafter: Special Offer) is INDIGO NAILS spółką z ograniczoną odpowiedzialnością with its registered office in Łódź, ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, 20th Commercial Division of the National Court Register under the KRS number: 0000919132, with NIP (Tax Identification Number): 7272792881 and REGON (Polish Business Registry Number) 101805889, (hereinafter: Indigo Nails) and Indigo Nails partners from whom it is possible to purchase Products covered by the Special Offer in accordance with item II sec. 2 c), d) and e) of the Regulations (hereinafter: Organizer), and for an individual Special Offer Participant, the Special Offer Organizer is always the entity with which the Participant concludes a sales contract.
- 2. The Special Offer is valid from May 19, 2022, 10:00:00 (CET GMT +1) to May 26, 2022, 23:59:59 (CET GMT +1) or while stocks last or the Special Offer is cancelled by the Organizer (hereinafter: Special Offer Validity).

II. Terms and conditions of the Special Offer

- 1. Both a consumer, i.e. a natural person who performs a legal transaction under the terms and conditions set out in these regulations, not directly related to their business or professional activity, as well as an entrepreneur, i.e. a natural person, legal person and organizational unit referred to in art. 331 § 1 of the Civil Code, conducting business or professional activity on their own behalf (hereinafter: Participant) may participate in the Special Offer.
- 2. The Participant takes part in the Special Offer by placing an order within the Special Offer Validity:

- e. at the sales representatives of the entities mentioned above.
- 3. The Special Offer applies to orders placed during the Special Offer, both in Poland and abroad.
- 4. The Participant undertakes not to resell the Products covered by the Special Offer in any way, in particular as part of the Participant's business activity. In the event of a breach of the above-mentioned provisions, the Organizer has the right to claim a refund of the value of the products that the Participant purchased as part of the Special Offer from the Participant, to

which the Participant, by accepting the Regulations and taking part in the Special Offer, agrees.

III. Principles of the Special Offer

- 1. During the Special Offer the Participant may purchase:

- 2. To take advantage of the Special Offer, enter the following discount code in the cart in the box "I have a discount code": "MAMASET" and click "Add". The -20% discount will be charged automatically after adding the above code.
- 3. This Special Offer cannot be combined with any other special offers for the products mentioned in the item above.
- 4. During the Special Offer each Participant may place any number of orders.
- 5. Indigo Nails reserves the right to change these Regulations during the Special Offer, without giving any reason, with the proviso that the rights acquired by the Participants before the change will be respected. In particular, Indigo Nails reserves the right to shorten the duration of the Special Offer or to exclude individual items from the Special Offer due to the depletion of stocks.

IV. Complaints and returns

- 1. All complaints regarding the manner of conducting the Special Offer should be submitted by the Participants by e-mail to the following e-mail address reklamacje@indigo-nails.com or by post to the address of the registered office of Indigo Nails specified in item 1 sec. 1 of the Regulations, with the note: "Mother's Day at Indigo" for the entire duration of the Special Offer, but not later than 14 days from the date of delivery of the order covered by the Special Offer.
- 2. The complaint should contain the following data of the Participant: name, surname and full address, as well as a detailed description and reason for the complaint, as well as the Participant's request.
- 3. Complaints submitted after the deadline or complaints which do not contain the information referred to in sec. 2 will not be considered. The date of sending the complaint is the date of the postmark on the shipment containing the complaint.
- 4. Complaints will be considered immediately, however not later than within 14 days from the date of their receipt by Indigo Nails.
- 5. If the provisions of generally applicable law grant the Participant the right to return the purchased products, the return of products purchased within the Special Offer is possible as long as the return covers the entire set of new and unused items purchased within the Special Offer. The customer can make a return only in relation to the Organizer within the meaning of item I sec. 1 of the Regulations.

V. Protection of personal data

- 1. The Organizer is the controller of the personal data of the Special Offer Participants.
- 2. Personal data collected in connection with the Special Offer will be processed in order to fulfil the order, for accounting purposes, as well as in the scope of pursuing claims and defence against claims resulting from sales contracts based on the controller's legitimate legal interest, which is pursuing claims and defence against claims.
- 3. Participants' personal data may be disclosed to entities supporting the Organizer in the implementation of the Special Offer, including in particular marketing agencies, courier companies, Poczta Polska.
- 4. Due to the processing of personal data by the Organizer, the Participants have the following rights:
- a. the right to access data and the right to request rectification, deletion or limitation of its processing.
- b. the right to transfer the provided personal data to another controller.
- c. the right to object to the processing of data.
- 5. The Participants also have the right to lodge a complaint with the President of the Office for Personal Data Protection.
- 6. The personal data of the Special Offer Participants will be kept for the period in which it is possible to submit a complaint, and in the case of a complaint for the time necessary to consider the complaint.
- 7. Providing personal data is voluntary, however, it is a necessary condition for the performance of the order. The consequence of not providing personal data will therefore be the inability to complete the order.

VI. Final provisions

- 1. The Special Offer Regulations are available at the registered office of each Organizer and on their website.
- 2. During the Special Offer, the order processing time may be extended.
- 3. By taking part in the Special Offer, the Participant accepts its principles contained in these Regulations and declares that he/she has read its principles set out in the Regulations and does not raise any objections in this regard.
