Regulations of the promotion "Indigo 2023 Fair Promotion"

I. Organiser and duration

- 1. The organiser of the promotion campaign "Indigo 2023 fair promotion" (hereafter: "Promotion") is INDIGO NAILS sp. z o.o with its registered office at Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs bytheDistrictCourtfor Łódź-Śródmieście in Łódź, XX Commercial Division of the National Court Register under KRS number: 0000919132, Tax ID: 7272792881 and REGON (National Business Registry Number 101805889, (hereafter: Indigo Nails) and partners of Indigo Nails, where the Products included in the Promotion may be purchased as outlined in pt. II sec. 2d) of the Regulations "Organiser"), whereby for a Participant of the Promotion, the Organiser of the Promotion is always the entity with which the Participant concludes a sales agreement.
- 2. The Promotion shall commence on 24 March 2023 at 08:00:00 (GMT +1 Central European Time) and terminate on 26 March 2023 at 23:59:59 (GMT +1 Central European Time) or when stocks are depleted, or the Organiser cancels the Promotion. (hereafter: the Promotion period).

II. Terms and conditions of the Promotion

- 1. The Promotion shall be open to consumers, i.e., natural persons performing a legal activity under the terms of these Regulations not directly related to their business or professional activity, and entrepreneurs, i.e. natural persons, legal entities and organisational units referred to in Article 33¹ § 1 of the Civil Code, who are self-employed (hereafter: Participant).
- 2. The Participant partakes in the Promotion by placing an order during the Promotion period:
- a. at the Indigo Nails online shop at https://www.indigo-nails.com/;
- b. in the Indigo Nails stationary shop at Ul. Senatorska 14/16 in Łódź. However, the possibility to use the Promotion in the stationary shop applies only to purchases made on 24.03.2023 between 9:00 and 17:00.
- c. at official points of sale, listed on the Indigo Nails website at: https://www.indigo-nails.com/pl,punkty-sprzedazy.html, which participate in the Promotion, as participation by the official points of sale is voluntary;
- d. at online shops operated by the entities listed above under pt. c);
- e. at the sales representatives of the entities indicated in pts. (a) to (d).
- 3. The Promotion applies to orders placed during the Promotion period both within and outside Poland.
- 4. The Participant undertakes not to resell the Products covered by the Promotion to any extent whatsoever, in particular as part of the Participant's business. In the event of a breach of the above provision, the Organiser is
- entitled to claim from the Participant a refund of the difference in the value of the products (between the standard price and the promotional price) that the Participant paid under the Promotion, and for which the Participant expresses consent by accepting the Regulations and participating in the Promotion.

III. Rules of the Promotion

- 1. During the Promotion, the Participant may purchase:
 - Hybrid bases and tops 7ml and 13ml at a discount of -20%, excluding Protein Base 7ml and 13ml, Protein Base Gold 7ml, BeautiCool Base Coat 7ml and Ideales Base Coat 7ml. After the discount in the shopping cart for the 7ml hybrid bases and tops, the price will be PLN 32.79/ € 8.72/ GBP 7.84. On the other hand, for the 13 ml bases and hybrid tops, it will be PLN 56.79/ € 14.8/ GBP 13.36.
 - Hybrid varnishes 7 ml with a discount of -20%, excluding hybrid varnishes from the SPRING 2023 collection. After the discount in the shopping cart for the 7ml hybrid varnish, the price will be PLN 29.59/ € 7.92/ GBP 7.2.
 - Self-Levelling Indigo gels 50ml discounted from PLN 129.00 (say: one hundred and twenty-nine 00/100 zloty) to PLN 115.00 (say: one hundred and fifteen 00/100 zloty)/ € 35/ GBP 30.
 - With the purchase of any two 300 ml creams or lotion, the customer will receive a 300 ml Black Madonna cream. Black Madonna cream 300 ml will be added to the shopping cart automatically at the price of the other two products.
- 2. This promotion does not combine with other promotions on Indigo Home SPA hand creams and lotions.
- 3. The promotion will accrue automatically when the products are added to the shopping cart.
- 4. Indigo Nails reserves the right to amend these Regulations during the Promotion without stating why, with the proviso that the rights acquired by the Participants before the change will be honoured. Particularly, Indigo Nails reserves the right to shorten the duration of the Promotion or to exclude specific products from the Promotion due to stock depletion.

IV. Complaints and returns

- 1. Any complaints regarding how the Promotion is conducted should be reported by Participants via email to reklamacje@indigo-nails.com or by post to the Organiser's registered office, with the note: "Indigo 2023 fair promotion" throughout the duration of the Promotion, but no later than 14 days from the date of delivery of the order covered by the Promotion.
- 2. The complaint should contain the following details of the party lodging the complaint: name, surname and exact address, as well as a detailed description and reason for the complaint and their demand.
- 3. Complaints submitted after the deadline or which do not contain the information referred to in sec.
- 2 shall not be considered. The date of delivery shall be:
- a) for complaints sent by post, the date of the postmark on the parcel containing the complaint;
- b) for complaints sent by e-mail, the date of confirmation of receipt of the e-mail by the Organiser.
- 4. Complaints will be examined immediately, but not later than within 14 days from the date of receipt by the Organizer.
- 5. Where the provisions of common law grant the Participant a right of return, the return of products purchased under the Promotion is possible, provided that it represents a whole set of new and unused

items purchased under the Promotion. The customer can only make the return to the Organiser as defined in pt. I, sec. 1 of the Regulations.

V. Personal data protection

- 1. The Organiser is the controller of the personal data of the Promotion Participants.
- 2. Personal data collected in connection with the Promotion shall be processed for order fulfilment, accounting and bookkeeping purposes, and the investigation of claims and defence against claims resulting from the Sales Agreement or the organisation of the Promotion in line with the Administrator's legitimate legal interest, i.e., the investigation of claims and defence against claims.
- 3. Participants' data may be disclosed to entities supporting the Organiser in implementing the Promotion, particularly marketing agencies, courier companies and the Polish Post Office.
- 4. In relation to the Organiser's processing of personal data, Participants possess the following rights: a. the right to access their data and the right to request rectification, deletion or restriction of data processing; b. the right to transfer the personal data provided to another controller; c. the right to object to data processing.
- 5. Participants are entitled to submit a complaint to the President of the Office for Data Protection.
- 6. The personal data of the Promotion Participants shall be retained for the complaint validity period and, in the case of a complaint, for the time necessary to process the complaint. Personal data relating to the performance of the Contract will be processed until the statute of limitations for claims resulting from the Contract.
- 7. The provision of personal data is voluntary but necessary to process the order. The order will be declined if personal data is not provided.

VI. Final provisions

- 1. These Regulations are available throughout the Promotion duration at the website www.indigo-nails.com.
- 2. These Regulations shall be effective as of 20.01.2023
- 3. During the Promotion period, lead times may be extended.
- 4. By participating in the Promotion, the Participant accepts the rules of the Promotion specified in these Regulations and declares that they have read the provisions therein and have no reservations in this respect.
