# Addition to "Crazy Deals" at Indigo Home SPA

**ADDITION of 23th of June 2020** 

to "Crazy Deals at Indigo home SPA" valid from 01st of September 2019

This addition introduces changes to the Terms and Conditions of the 'Crazy Deals at Indigo home SPA' offer

**§1.** 

Amendments to point I para. 2 of the T&Cs referring to the duration of the Offer, which reads as follows:

"The offer runs from 01st September 2019, until 24th June 09:59:59 (hereinafter referred to as 'Duration Time')."

**§2.** 

Other provisions of the T&Cs remain unchanged. Hence the current consolidated text of the T&Cs of the Offer 'Crazy Deals at Indigo home SPA' reads:

## Special offer 'Crazy Deals' at Indigo Home SPA

### I. Promoter and time frame

- 1. Promoter of 'Crazy Deals at Indigo Home Spa' (hereinafter referred to as 'Special Offers') is Indigo Nails Limited Liability Company limited partnership with registered address (headquarters) at ul. Gen. Lucjana Żeligowskiego 3/5, 90-752 Łódź, entered into the Companies Register by the District Court Łódź Śródmieście Łódź, XX Commercial Department of the National Court Register under the number KRS: 0000684415, REGON 101805889, NIP 7272792881, hereinafter referred to as 'Indigo Nails', and partners of Indigo Nails, from which it is possible to purchase Products covered by the Special Offers in accordance with point II of Terms & Conditions (hereinafter referred to as the 'Promoter'), while for specific Special Offer Participant the Special Offer Promoter is always the entity with which the Participant concludes a sales agreement.
- 2. The 'Crazy Deals' runs from 1<sup>st</sup> September 2019, until stocks last or until it is canceled, subject to point III point 3.22 of T&C.

## **II. General Terms and Conditions**

1. Indigo Nails 'Crazy Deals' special offer is open to both the consumer not directly related to its business or professional activity, as well as a professional running business or professional activity (referred to in art. 331 § 1 of the Civil Code) (hereinafter referred to as the Participant), who will place an order during the special offer:

- o At the Indigo online store;
- o At the Indigo retail store;

- o At online store operated by official sale point, referred to in point c above;
- o At official stores operated by agents, referred to in point c above.
- 2. The 'Crazy Deals' applies to orders placed during the special offer both in Poland and other countries.

## III. The 'Crazy Deals' Terms and Conditions

- 1. The 'Crazy Deals' applies to orders placed from 1<sup>st</sup> September 00:00 until stocks last or special offer is canceled by the Promoter.
- 2. With the purchase of 5 items of hand creams 300 ml or body lotions 300 ml (products can be mixed), the price will go down to 31PLN/7.40 EURO/6.70 GBP per item.
- 3. With the purchase of 10 items of hand creams 300 ml or body lotions 300 ml (products can be mixed), the price will go down to 28PLN/6.70 EURO/6.10 GBP per item.
- 4. With the purchase of 15 items of hand creams 300 ml or body lotions 300 ml (products can be mixed), the price will go down to 24PLN/5.70 EURO/5.20 GBP per item.
- 5. With the purchase of 5 INDIGO Shea Sugar Body Scrub 500 g, the price will go down to 62 PLN/14.80 EURO/13.50 GBP per item.
- 6. With the purchase of 10 INDIGO Shea Sugar Body Scrub 500 g, the price will go down to 60 PLN/14.30 EURO/13 GBP per item.
- 7. With the purchase of 15 INDIGO Shea Sugar Body Scrub 500 g, the price will go down to 58 PLN/13.80 EURO/12.60 GBP per item.
- 8. With the purchase of 5 INDIGO Shea Sugar 75 ml, the price will go down to 30 PLN/7.10 EURO/6.50 GBP per item.
- 9. With the purchase of 10 INDIGO Shea Sugar 75 ml, the price will go down to 28 PLN/6.70 EURO/6.10 GBP per item.
- 10. With the purchase of 15 INDIGO Shea Sugar 75 ml, the price will go down to 26 PLN/6.20 EURO/5.70 GBP per item.
- 11. With the purchase of 5 INDIGO Argan Oil 100 ml, the price will go down to 30 PLN/7.10 EURO/6.50 GBP per item.
- 12. With the purchase of 10 INDIGO Argan Oil 100 ml, the price will go down to 28 PLN/6.70 EURO/6.10 GBP per item.
- 13. With the purchase of 15 INDIGO Argan Oil 100 ml, the price will go down to 26 PLN/6.20 EURO/5.70 GBP per item.
- 14. With the purchase of 5 INDIGO Foot Lover Seventh Heaven feet cream, the price will go down to 23 PLN/5.50 EURO/5.00 GBP per item.
- 15. With the purchase of 10 INDIGO Foot Lover Seventh Heaven feet cream, the price will go down to 21 PLN/5.00 EURO/4.60 GBP per item.
- 16. With the purchase of 15 INDIGO Foot Lover Seventh Heaven feet cream, the price will go down to 18 PLN/4.30 EURO/3.90 GBP per item.
- 17. With the purchase of 5 INDIGO Shea Elixir 8ml, the price will go down to 8.90 PLN/2.10 EURO/1.90 GBP per item.
- 18. With the purchase of 10 INDIGO Shea Elixir 8ml, the price will go down to 7.90 PLN/1.90 EURO/1.70 GBP per item.

- 19. With the purchase of 15 INDIGO Shea Elixir 8ml, the price will go down to 6.90 PLN/1.60 EURO/1.50 GBP per item.
- 20. The 'Cray Deals' applies to INDIGO Body Lotion 300ml, Hand Cream 300 ml, INDIGO Shea Sugar Body Scrub 500 g, INDIGO shea Butter 75 ml, INDIGO Argan Oil 100 ml, INDIGO Foot Lover Seventh Heaven Feet Cream, INDIGO Shea Elixir 8ml;
- 21. The number of orders per person is not limited.
- 22. The Promoter reserves the right at any time in its sole discretion to cancel, modify or supersede T&C of the 'Crazy Deals at any time without notice. The rights acquired by the Participants before the change will be respected. The Promoter reserves the right to limit the range of products due to the out of stock. Promoter reserves the right at any time in its sole discretion to cancel, modify or supersede T&C of the 'Crazy Deals at any time without a notice, if it believes, in its sole discretion, that the special offer is not capable or is likely not to be capable of being conducted fairly or as specified within these terms and conditions due to events beyond its control. The rights acquired by the Participants before the change will be respected. The Promoter reserves the right to limit the range of products due to the out of stock.
- 23. For any Promoter other than Indigo Nails, the prices indicated in points 2-19 of this section are only suggested prices. Before placing the order, each Participant should make sure that the Special Offer applies to the given Promoter, as well as whether the price for promotional products is not lower or higher than indicated in T&Cs.

## **IV.** Complaints

- 1. All complaints regarding Special Offer shall be submitted via e-mail to reklamacje@indigo-nails.com or by post to Promoter's head office with reference: 'Crazy Deals at Indigo Home Spa complaint.' Any claims must be received before Special Offer ends and within 14 days of receipt of order.
- 2. The complaint should include the following details: name, surname, and full address of person reporting, detailed description and reason for the complaint, as well as the resolution request.
- 3. Complaints submitted after Special Offers ends or not including the information referred to in paragraph 2 will not be considered. The date of posting the complaint is the date on the postage stamp on the package containing the complaint.
- 4. Complaints will be considered immediately, however not later than within 14 days from the day they are received by the Promoter.

#### V. Data Protection

- 1. Personal Data of Participants will be processed by the Promoter.
- 2. Personal data collected in connection with 'Crazy Deals' offer will be processed in order to:
  - o Order processing
  - o Accounting
  - Pursuing claims and defense against claims arising from the Sales Agreement based on the Administrator's legitimate legal interest in pursuing claims and defending against claims
- 3. Personal data of Participants may be disclosed to entities supporting the Promoter in the implementation of the Competition, including in particular marketing agencies, courier companies, accounting office, law firm, postal and courier services operator.

- 4. In connection with personal data processing by the Promoter, Participants have the following rights:
  - 1. the right to access personal data and the right to request rectification, deletion, or restrictions on their processing
  - 2. the right to transfer personal data provided to another data administrator
  - 3. the right to object to data processing
- 5. Participants also have the right to lodge a complaint with the President of the Office for Personal Data Protection.
- 6. Personal data of 'Crazy Deals' Participants will be stored for the period during which complaints will be possible, and in the case of complaints for the time necessary to consider the complaint.
- 7. Providing personal data is voluntary; however, it is required for order completion. Not providing personal data will effect in inability to process the order.

## VI. Final provisions

- 1. The 'Crazy Deals' offer T&Cs are available at the Promoter's head office or <u>indigonals.com</u>
- 2. Orders processing might be longer due to a number of orders during Special Offer.
- 3. The Participants of 'Crazy Deals' offer automatically accept T&Cs that apply to this offer.
- 4. All Participants of the 'Crazy Deals' offer declare that they have read the T&Cs and accept all its conditions.
